1 A BILL TO BE ENTITLED
2 AN ACT TO REQUIRE WITHHOLDING FROM CERTAIN PAYMENTS TO
3 NONRESIDENTS IN ORDER TO PREVENT NONRESIDENTS FROM
4 AVOIDING NORTH CAROLINA INCOME TAXES AND TO CONFORM TO
5 FEDERAL RULES ON WAGE WITHHOLDING BY FARMERS.
6 The General Assembly of North Carolina enacts:
7 Section 1. G.S. 105-163.1(15) reads as rewritten:
8 "(15) Wages. – The term has the same meaning as in section 3401 of the
9 Code except it does not include ~~remuneration paid by a farmer for~~
10 ~~services performed on the farmer's farm in producing or harvesting~~
11 ~~agricultural products or in transporting the agricultural products to~~
12 ~~market.~~ either of the following:
13 a. Remuneration paid by a farmer for services performed on the
14 farmer's farm in producing or harvesting agricultural products or
15 in transporting the agricultural products to market.

- 1 b. The amount of severance wages paid to an employee during the
2 taxable year that is exempt from State income tax for that taxable
3 year under G.S. 105-134.6(b)(11)."

4 Section 2. Article 4A of Chapter 105 of the General Statutes, as amended by
5 Section 1 of this act, reads as rewritten:

11 The following definitions apply in this Article:

- 15 nonresident individual or a nonresident entity compensation for personal
- 16 services performed in this State.
- 17 (11) Payroll period. – A period for which an employer ordinarily pays wages
- 18 to an employee of the employer.
- 19 (12) Taxable year. – Defined in section 441(b) of the Code.

31 **"§ 105-163.2. ~~Withholding.~~ Employers must withhold taxes.**

32 (a) Withholding Required. – An employer shall deduct and withhold from the
33 wages of each employee the State income taxes payable by the employee on the wages.
34 For each payroll period, the employer shall withhold from the employee's wages an
35 amount that would approximate the employee's income tax liability under Article 4 of
36 this Chapter if the employer withheld the same amount from the employee's wages for
37 each similar payroll period in a calendar year. In calculating an employee's anticipated
38 income tax liability, the employer shall allow for the exemptions, deductions, and credits
39 to which the employee is entitled under Article 4 of this Chapter. The amount of State
40 income taxes withheld by an employer is held in trust for the Secretary.

41 (b) Withholding Tables. – The manner of withholding and the amount to be
42 withheld shall be determined in accordance with tables and rules adopted by the
43 Secretary. The withholding exemption allowed by these tables and rules shall, as nearly

1 as possible, approximate the exemptions, deductions, and credits to which an employee
2 would be entitled under Article 4 of this Chapter. The Secretary shall ~~cause to be prepared~~
3 ~~and shall~~ promulgate tables for computing amounts to be withheld with respect to
4 different rates of wages for different payroll periods applicable to the various
5 combinations of exemptions to which an employee may be entitled and taking into
6 account the appropriate standard deduction. The tables may provide for the same amount
7 to be withheld within reasonable salary brackets or ranges so designed as to result in the
8 withholding during a year of approximately the amount of an employee's indicated
9 income tax liability for that year. The withholding of wages pursuant to and in
10 accordance with these tables shall be deemed as a matter of law to constitute compliance
11 with the provisions of subsection (a) of this section, notwithstanding any other provisions
12 of this Article.

13 (c) Withholding if No Payroll Period. – If wages are paid with respect to a period
14 ~~which that~~ is not a payroll period, the amount to be deducted and withheld shall be that
15 applicable in the case of a miscellaneous payroll period containing a number of days,
16 excluding Sundays and holidays, equal to the number of days in the period with respect to
17 which such wages are paid. ~~(d) In paid.~~ In any case in which wages are paid by an
18 employer without regard to any payroll period or other period, the amount to be deducted
19 and withheld shall be that applicable in the case of a miscellaneous payroll period
20 containing a number of days equal to the number of days, excluding Sundays and
21 holidays, which have elapsed since the date of the last payment of such wages by such
22 employer during the calendar year, or the date of commencement of employment with
23 such employer during such year, or January 1 of such year, whichever is the later.

24 (d) Estimated Withholding. – The Secretary may, by rule, authorize employers to
25 estimate the wages to be paid to an employee during a calendar quarter, calculate the
26 amount to be withheld for each period based on the estimated wages, and, upon payment
27 of wages to the employee, adjust the withholding so that the amount actually withheld is
28 the amount that would be required to be withheld if the employee's payroll period were
29 quarterly.

30 (e) Alternatives to Tables. – If the Secretary determines that use of the
31 withholding tables would be impractical, would impose an unreasonable burden on an
32 employer, or would produce substantially incorrect results, the Secretary may authorize
33 or require an employer to use some other method of determining the amounts to be
34 withheld under this Article. The alternative method authorized by the Secretary must
35 reasonably approximate the predicted income tax liability of the affected employees. In
36 addition, with the agreement of the employer and employee, the Secretary may authorize
37 an employer to use an alternative method that results in withholding of a greater amount
38 than otherwise required under this section.

39 The Secretary's authorization of an alternative method is discretionary and may be
40 cancelled at any time without advance notice if the Secretary finds that the method is
41 being abused or is not resulting in the withholding of an amount reasonably
42 approximating the predicted income tax liability of the affected employees. The
43 Secretary shall give an employer written notice of any cancellation and the findings upon

1 which the cancellation is based. The cancellation becomes effective upon the employer's
2 receipt of this notice or on the third day after the notice was mailed to the employer,
3 whichever occurs first. If the employer requests a hearing on the cancellation within 30
4 days after the cancellation, the Secretary shall grant a hearing. After a hearing, the
5 Secretary's findings are conclusive.

6 (e) ~~The Secretary may, by regulations, authorize employers:~~

7 (1) ~~To estimate the wages which will be paid to any employee in any~~
8 ~~quarter of the calendar year;~~

9 (2) ~~To determine the amount to be deducted and withheld upon each~~
10 ~~payment of wages to such employee during such quarter as if the~~
11 ~~appropriate average of the wages so estimated constituted the actual~~
12 ~~wages paid; and~~

13 (3) ~~To deduct and withhold upon any payment of wages to such employee~~
14 ~~during such quarter such amount as may be necessary to adjust the~~
15 ~~amount actually deducted and withheld upon the wages of such~~
16 ~~employee during such quarter to the amount that would be required to~~
17 ~~be deducted and withheld during such quarter if the payroll period of the~~
18 ~~employee was quarterly.~~

19 (f) ~~The Secretary is authorized in unusual circumstances wherein he finds that the~~
20 ~~use of the prescribed tables is impracticable or constitutes an unreasonable requirement of~~
21 ~~the employer to authorize such employer to use some other method of determining the~~
22 ~~amounts to be withheld under this Article, provided the amounts withheld under such~~
23 ~~other method will reasonably approximate the indicated income tax liability of his~~
24 ~~employees. Further, the Secretary may authorize an employer to use another method for~~
25 ~~determining the amounts to be withheld under the provisions of this Article from the~~
26 ~~wages or salaries of groups of employees or individual employees if the circumstances~~
27 ~~are such that the use of the tables would produce substantially incorrect results. Any~~
28 ~~authorization of the use of a different method shall be subject to review and cancellation~~
29 ~~or alteration by the Secretary every twelfth month, and the Secretary may cancel such~~
30 ~~authorization or order an alteration of such method at any time upon a finding by him that~~
31 ~~such authorization is being abused or that such method is not resulting in the withholding~~
32 ~~of a sum reasonably approximating the indicated income tax liability of the employees,~~
33 ~~which finding may be made by the Secretary with or without notice or a hearing and shall~~
34 ~~be conclusive except as hereinafter provided. The Secretary shall notify the employer in~~
35 ~~writing of his finding and order thereon, and such notice shall be deemed to have been~~
36 ~~received by the employer on the third day after having been deposited in the mail and the~~
37 ~~employer shall thereafter abide by such order. Any employer feeling aggrieved by such~~
38 ~~order may thereafter apply for a hearing thereon before the Secretary, unless a hearing~~
39 ~~has been previously held, and upon such hearing the findings of the Secretary shall be~~
40 ~~deemed conclusive.~~

41 (g) ~~The Secretary is authorized to provide by regulation, under such conditions and~~
42 ~~to such extent as he deems proper, for withholding in addition to that otherwise required~~
43 ~~under this section in cases in which the employer and the employee agree to such~~

1 additional withholding. Such additional withholding shall for all purposes be treated as
2 other withholding amounts required to be deducted and withheld under this Article.

3 (h) ~~The act of compliance with any of the provisions of this Article by a~~
4 ~~nonresident employer shall not constitute an act in evidence of and shall not be deemed to~~
5 ~~be evidence that such nonresident is doing business in this State.~~

6 "§ 105-163.3. Withholding in accordance with regulations. ~~Certain payers must~~
7 withhold taxes.

8 (a) Requirement. – Every payer who pays a contractor more than six hundred
9 dollars (\$600.00) during a calendar year shall deduct and withhold from compensation
10 paid to a contractor the State income taxes payable by the contractor on the compensation
11 as provided in this section. The amount of taxes to be withheld is four percent (4%) of
12 the compensation paid to the contractor. The taxes a payer withholds are held in trust for
13 the Secretary.

14 (b) Exemptions. – The withholding requirement does not apply to the following:

15 (1) Compensation that is subject to the withholding requirement of G.S.
16 105-163.2.

17 (2) Compensation paid to an ordained or licensed member of the clergy.

18 (c) Returns; Due Date. – A payer shall file a return with the Secretary on a form
19 prepared by the Secretary and shall provide any information required by the Secretary.
20 The return is due and the withheld taxes are payable by the last day of the first month
21 after the end of each calendar quarter during which the payer pays compensation to a
22 contractor. The Secretary may extend the time for filing the return or paying the tax as
23 provided in G.S. 105-263.

24 (d) Annual Statement; Report to Secretary. – A payer required to deduct and
25 withhold from a contractor's compensation under this section shall furnish to the
26 contractor duplicate copies of a written statement showing the following:

27 (1) The payer's name, address, and taxpayer identification number.

28 (2) The contractor's name, address, and taxpayer identification number.

29 (3) The total amount of compensation paid during the calendar year.

30 (4) The total amount deducted and withheld under this section during the
31 calendar year.

32 This statement is due by January 31 following the calendar year. If the personal services
33 for which the payer is paying are completed before the end of the calendar year and the
34 contractor requests the statement, the statement is due within 45 days after the payer's last
35 payment of compensation to the contractor. The Secretary may require the payer to
36 include additional information on the statement.

37 Each payer shall file with the Secretary an annual report that compiles the information
38 contained in each of the payer's statements to contractors and any other information
39 required by the Secretary. This report is due on the date prescribed by the Secretary and
40 is in lieu of the information report required by G.S. 105-154.

41 (e) Records. – If a payer does not withhold from payments to a nonresident
42 corporation or a nonresident limited liability company because the entity has obtained a
43 certificate of authority from the Secretary of State, the payer shall obtain from the entity

1 its corporate identification number issued by the Secretary of State. If a payer does not
2 withhold from payments to an individual because the individual is a resident, the payer
3 shall obtain the individual's address and social security number. If a payer does not
4 withhold from a partnership because the partnership has a permanent place of business in
5 this State, the payer shall obtain the partnership's address and taxpayer identification
6 number. The payer shall retain this information with its records.

7 (f) Payer May Repay Amounts Withheld Improperly. – A payer may refund to a
8 person any amount the payer withheld improperly from the person under this section, if
9 the refund is made before the end of the calendar year and before the payer furnishes the
10 person the annual statement required by subsection (d) of this section. An amount is
11 withheld improperly if it is withheld from a payment to a person who is not a contractor,
12 if it is withheld from a payment that is not compensation, or if it is in excess of the
13 amount required to be withheld under this section. A payer who makes a refund under
14 this section must:

15 (1) Not report the amount refunded on the annual statement required by
16 subsection (d); and

17 (2) Either not pay to the Secretary the amount refunded or, if the amount
18 refunded has already been paid to the Secretary, reduce by the amount
19 refunded the next payments to the Secretary of taxes withheld from the
20 person.

21 ~~The manner of withholding and the amount to be deducted and withheld under G.S.~~
22 ~~105-163.2 shall be determined in accordance with tables, rules, and regulations adopted~~
23 ~~by the Secretary. The withholding exemption allowed by these tables, rules, and~~
24 ~~regulations shall, as nearly as possible, approximate the exemptions, deductions, and~~
25 ~~credits to which an employee would be entitled under Article 4 of this Chapter.~~

26 **"§ 105-163.4. Withholding does not create nexus.**

27 A nonresident withholding agent's act in compliance with this Article does not in
28 itself constitute evidence that the nonresident is doing business in this State.

29 **No withholding from reimbursement for expenses.**

30 ~~The amount an employer pays an employee as reimbursement for ordinary and~~
31 ~~necessary expenses incurred by the employee on behalf of the employer and in the~~
32 ~~furtherance of the business of the employer is not wages and is not subject to withholding~~
33 ~~under this Article.~~

34 **"§ 105-163.5. Exemptions—Employee exemptions allowable; certificates.**

35 (a) An employee receiving wages shall be is entitled to the exemptions for which
36 such the employee qualifies under the provisions of Article 4 of this Chapter.

37 (b) Every employee shall, on or before January 1, 1960, or at the time of
38 commencing employment, whichever is later, furnish his or her employer with a signed
39 withholding exemption certificate informing the employer of the exemptions the
40 employee claims, which in no event shall exceed the amount of exemptions to which the
41 employee is entitled under the Code; but, in the event that Code. If the employee fails to
42 file the exemption certificate the employer, in computing amounts to be withheld from

1 the employee's wages, shall allow the employee the exemption accorded a single person
2 with no dependents.

3 (c) Withholding exemption certificates shall take effect as of the beginning of the
4 first payroll period ~~which that~~ ends on or after the date on which ~~such the~~ certificate is
5 furnished, or if payment of wages is made without regard to a payroll period, then ~~such~~
6 the certificate shall take effect as of the beginning of the miscellaneous payroll period for
7 which the first payment of wages is made on or after the date on which ~~such the~~
8 certificate is ~~furnished; provided, that certificates furnished before January 1, 1960, shall be~~
9 ~~deemed to have been furnished on that date.~~ furnished.

10 (d) If, on any day during the calendar year, the amount of withholding exemptions
11 to which the employee is entitled is less than the amount of withholding exemptions
12 claimed by the employee on the withholding exemption certificate then in effect with
13 respect to ~~him, the employee,~~ the employee, the employee shall, within 10 days thereafter, furnish the
14 employer with a new withholding exemption certificate ~~relating to~~ stating the amount of
15 withholding exemptions which the employee then claims, which shall in no event exceed
16 the amount to which ~~he the employee~~ is entitled on ~~such that~~ day. If, on any day during
17 the calendar year, the amount of withholding exemptions to which the employee is
18 entitled is greater than the amount of withholding exemptions claimed, the employee may
19 furnish the employer with a new withholding exemption certificate ~~relating to~~ stating the
20 amount of withholding exemptions which the employee then claims, which shall in no
21 event exceed the amount to which ~~he the employee~~ is entitled on ~~such that~~ day.

22 (e) Withholding exemption certificates ~~shall be in such form and contain such~~
23 ~~information as the Secretary may prescribe, but, insofar~~ must be in the form and contain the
24 information required by the Secretary. As far as practicable, the Secretary shall cause the
25 form of ~~such the~~ certificates to be substantially similar to federal exemption certificates.

26 (f) In addition to any criminal penalty provided by law, if an individual furnishes
27 his or her employer ~~with~~ an exemption certificate that contains information which has no
28 reasonable basis and that results in a lesser amount of tax being withheld under this
29 Article than would have been withheld if the individual had furnished reasonable
30 information, the individual is subject to a penalty of fifty percent (50%) of the amount not
31 properly withheld.

32 **"§ 105-163.6. When employer must file returns and pay withheld taxes.**

33 (a) General. – A return is due quarterly or monthly as specified in this section. A
34 return shall be filed with the Secretary on a form prepared by the Secretary, shall report
35 any payments of withheld taxes made during the period covered by the return, and shall
36 contain any other information required by the Secretary.

37 Withheld taxes are payable quarterly, monthly, or semiweekly, as specified in this
38 section. If the Secretary finds that collection of the amount of taxes this Article requires
39 an employer to withhold is in jeopardy, the Secretary may require the employer to file a
40 return or pay withheld taxes at a time other than that specified in this section.

41 (b) Quarterly. – An employer who withholds an average of less than five hundred
42 dollars (\$500.00) of State income taxes from wages each month shall file a return and pay

1 the withheld taxes on a quarterly basis. A quarterly return covers a calendar quarter and is
2 due by the last day of the month following the end of the quarter.

3 (c) Monthly. – An employer who withholds an average of at least five hundred
4 dollars (\$500.00) but less than two thousand dollars (\$2,000) from wages each month
5 shall file a return and pay the withheld taxes on a monthly basis. A return for the months
6 of January through November is due by the 15th day of the month following the end of
7 the month covered by the return. A return for the month of December is due the
8 following January 31.

9 (d) Semiweekly. – An employer who withholds an average of at least two
10 thousand dollars (\$2,000) of State income taxes from wages each month shall file a return
11 by the date set under the Code for filing a return for federal employment taxes
12 attributable to the same wages and shall pay the withheld State taxes by the date set under
13 the Code for depositing or paying federal employment taxes attributable to the same
14 wages. The date set by the Code for depositing or paying federal employment taxes shall
15 be determined without regard to § 6302(g) of the Code.

16 An extension of time granted to file a return for federal employment taxes attributable
17 to wages is an automatic extension of time for filing a return for State income taxes
18 withheld from the same wages, and an extension of time granted to pay federal
19 employment taxes attributable to wages is an automatic extension of time for paying
20 State income taxes withheld from the same wages. An employer who pays withheld State
21 income taxes under this subsection is not subject to interest on or penalties for a shortfall
22 in the amount due if the employer would not be subject to a failure-to-deposit penalty had
23 the shortfall occurred in a deposit of federal employment taxes attributable to the same
24 wages and the employer pays the shortfall by the date the employer would have to
25 deposit a shortfall in the federal employment taxes.

26 (e) Category. – The Secretary shall monitor the amount of taxes withheld by an

32 (a) Every employer required to deduct and withhold from an employee's wages
33 under G.S. 105-163.2 shall furnish to ~~each such the~~ employee in respect to the
34 remuneration paid by ~~such the~~ employer to such employee during the calendar year, on or
35 before January 31 of the succeeding year, or, if ~~his the~~ employment is terminated before
36 the close of ~~such the~~ calendar year, within 30 days ~~from after~~ the date on which the last
37 payment of remuneration is made, duplicate copies of a written statement showing the

2 (b) The Secretary may require an employer to include information not listed in
3 subsection (a) on the employer's written statement to an employee and to file the
4 statement at a time not required by subsection (a). Every employer shall file an annual
5 report with the Secretary that contains the information given on each of the employer's
6 written statements to an employee and other information required by the Secretary. The
7 annual report is due on the same date the employer's federal information return of federal
8 income taxes withheld from wages is due under the Code. The report required by this
9 subsection is in lieu of the report required by G.S. 105-154.

10 (c) An employer who is required to file an annual report under subsection (b) of
11 this section must report to the Secretary the following information concerning
12 compliance with Article 1 of Chapter 97 of the General Statutes, the Workers'
13 Compensation Act:

14 (1) Whether the employer is required to maintain insurance or qualify as a
15 self-insured employer under the provisions of G.S. 97-93.

16 (2) Whether the employer is insured, self-insured through a group, or
17 individually self-insured.

18 (3) The name of the employer's workers' compensation insurance carrier
19 and the number and expiration date of the insurance policy if the
20 employer has workers' compensation insurance.

21 (4) The name of the self-insured group, the group's third-party
22 administrator, and the group's or employer's self-insured code number
23 used by the Department of Insurance, if the employer is a member of a
24 self-insured group.

25 (5) The name of the employer's third-party administrator and the employer's
26 self-insured code number used by the Department of Insurance, if the
27 employer is individually self-insured.

28 (6) Whether any information reported to the Secretary on a previous return
29 has changed.

30 The Secretary must compile the information concerning workers' compensation
31 reported by employers on an annual report and must give the compiled data to the
32 Industrial Commission.

15 calendar year from the wages or compensation of any an individual shall be allowed as a
16 credit to that individual against the tax imposed by ~~G.S. 105-134.2~~ Article 4 of this
17 Chapter for taxable years beginning in that calendar year. The amount deducted and
18 withheld under this Article during any calendar year from the compensation of a
19 nonresident entity shall be allowed as a credit to that entity against the tax imposed by
20 Article 4 of this Chapter for taxable years beginning in that calendar year. If the
21 nonresident entity is a pass-through entity, the entity shall pass through and allocate to
22 each owner the owner's share of the credit.

32 (a) In the case of any underpayment of the estimated tax by an individual, there
33 shall be added to the tax imposed under Article 4 for the taxable year an amount
34 determined by applying the applicable annual rate established under G.S. 105-241.1(i) to
35 the amount of the underpayment for the period of the underpayment.

36 (b) For purposes of subsection (a), the amount of the underpayment shall be the
37 excess of the required installment, over the amount, if any, of the installment paid on or
38 before the due date for the installment. The period of the underpayment shall run from the
39 due date for the installment to whichever of the following dates is the earlier: (i) the
40 fifteenth day of the fourth month following the close of the taxable year, or (ii) with
41 respect to any portion of the underpayment, the date on which such portion is paid. A
42 payment of estimated tax shall be credited against unpaid required installments in the
43 order in which such installments are required to be paid.

1 (c) For purposes of this section there shall be four required installments for each
2 taxable year with the time for payment of the installments as follows:

- 3 (1) First installment – April 15 of taxable year;
- 4 (2) Second installment – June 15 of taxable year;

18 annualized income installment is less than the amount determined under subsection (d),
19 the amount of the required installment shall be the annualized income installment, and
20 any reduction in a required installment resulting from the application of this subsection
21 shall be recaptured by increasing the amount of the next required installment determined
22 under subsection (d) by the amount of the reduction and by increasing subsequent
23 required installments to the extent that the reduction has not previously been recaptured.

24 In the case of any required installment, the annualized income installment is the
25 excess, if any, of (i) an amount equal to the applicable percentage of the tax for the
26 taxable year computed by placing on an annualized basis the taxable income for months
27 in the taxable year ending before the due date for the installment, over (ii) the aggregate
28 amount of any prior required installments for the taxable year. The taxable income shall
29 be placed on an annualized basis under rules prescribed by the Secretary. The applicable
30 percentages for the required installments are as follows:

- 31 (1) First installment – twenty-two and one-half percent (22.5%);
- 32 (2) Second installment – forty-five percent (45%);
- 33 (3) Third installment – sixty-seven and one-half percent (67.5%); and
- 34 (4) Fourth installment – ninety percent (90%).

35 (f) No addition to the tax shall be imposed under subsection (a) if the tax shown

38 any liability for tax under Division II of Article 4 for the preceding taxable year.

39 (g) For purposes of this section, the term 'tax' means the tax imposed by Division

25 oyster farming, shown on the return of the individual for the preceding taxable year is at
26 least sixty-six and two-thirds percent (66 2/3%) of the total gross income from all sources
27 shown on the return.

28 (j) In applying this section to a taxable year beginning on any date other than
29 January 1, there shall be substituted, for the months specified in this section, the months
30 that correspond thereto. This section shall be applied to taxable years of less than 12
31 months in accordance with rules prescribed by the Secretary.

32 (k) This section shall not apply to any estate or trust.

33 **"§ 105-163.16. Overpayment refunded.**

34 If the amount of wages or compensation withheld at the source under ~~G.S. 105-163.2~~
35 this Article exceeds the tax imposed by Article 4 of this Chapter against which the
36 withheld tax is credited under G.S. 105-163.10, the excess is considered an overpayment
37 by the ~~employee-employee or contractor.~~ If the amount of estimated tax paid under G.S.
38 105-163.15 exceeds the taxes imposed by Article 4 of this Chapter against which the
39 estimated tax is credited under the provisions of this Article, the excess is considered an
40 overpayment by the taxpayer. An overpayment shall be refunded as provided in Article 9
41 of this Chapter.

9 The Secretary of Revenue may, with the approval of the Attorney General, enter into
10 agreements with the taxing authorities of states having income tax withholding statutes
11 with such agreements to govern the amounts to be withheld from the wages and salaries
12 of residents of such other state or states under the provisions of this Article when such
13 other state or states grant similar treatment to the residents of this State. Such agreements
14 may provide for recognition of the anticipated tax credits allowed under the provisions of
15 G.S. 105-151 in determining the amounts to be withheld.

16 "**§ 105-163.23. Withholding from federal employees.**

17 The Secretary of Revenue ~~is hereby~~ is designated as the proper official to make request
