A BILL TO BE ENTITLED

AN ACT TO AMEND THE CHARTER OF THE TOWN OF SHALLOTTE TO  
AUTHORIZE THE TOWN TO ENFORCE ORDINANCES AS PROVIDED IN THE  
GENERAL LAW, TO ANNEX PROPERTY TO THE TOWN OF SHALLOTTE,  
AND TO CORRECT AN ERROR IN THE DESCRIPTION OF DISTRICTS IN THE  
WHITEVILLE CITY SCHOOL ADMINISTRATIVE UNIT.

The General Assembly of North Carolina enacts:

Section 1. Section 9 of the Charter of Shallotte, being Chapter 339 of the  
Public Laws of 1899, reads as rewritten:

"Sec. 9. Violations.

~~Any person violating any ordinance of said town shall be deemed guilty of a  
misdemeanor, but the punishment thereof upon conviction shall not exceed a fine of \$50  
or imprisonment for 30 days. The provisions of G.S. 160A-175 govern violations and  
enforcement of ordinances adopted by the Board of Aldermen."~~

Section 2. The corporate limits of the Town of Shallotte are extended to  
include the following described area:

Being all of that tract of land containing 35.30 acres, more or less, lying  
adjacent to Town of Shallotte, Shallotte and Waccamaw Townships, Brunswick County,

1 N.C., and encompassing the 100 foot right-of-way of N.C. Highway 130; and, being  
2 more particularly described by courses based on N.C. Grid North per N.C. Department of  
3 Transportation highway plans project number 8.1310802 R-97E and distances according  
4 to a survey by Jimmy D. Etheridge, R.L.S. No. 3415 and Bobby M. Long and Associates,  
5 dated May 16, 1997.

6 Commencing at an existing N.C. Department of Transportation right-of-way  
7 monument located at station number 23+78 Ramp "B" 80 foot left as shown on N.C.  
8 Department of Transportation highway plans, project number 8.1310802 R 97-E, and  
9 having N.C. Grid coordinates: North = 83078.5066 feet, East = 2179691.659 feet; thence  
10 running north 48 degrees 14 minutes 03 seconds west 183.70 feet to a right-of-way  
11 monument, thence north 15 degrees 20 minutes 39 seconds west a chord distance of  
12 65.48 feet to a right-of-way monument located on the southern right-of-way line of N.C.  
13 Highway 130, 100 foot right-of-way, thence running with the said right-of-way line north  
14 61 degrees 53 minutes 17 seconds west 69.89 feet to an existing iron, thence north 61

40 the point and place of beginning. Said survey having an error of closure of 1 to 7500+.

41 Section 3. Section 4 of Chapter 661 of the 1995 Session Laws reads as  
42 rewritten:

1 "Sec. 4. District 1 consists of all of Whiteville City Council District #1 as it was  
2 bounded for the 1995 municipal election, but excluding any territory not in the city limits  
3 as of January 1, 1990.

4 District 2 consists of all of Whiteville City Council District #2 as it was bounded for  
5 the 1995 municipal election, but excluding any territory not in the city limits as of  
6 January 1, 1990, and in addition includes the following areas:

7 Beginning at the point where the centerline of US Highway 74 Business intersected the  
8 western corporate limits of the Town of Whiteville on January 1, 1990, thence following  
9 the centerline of US Highway 74 Business in a westerly direction to ~~the~~  
10 ~~Whiteville/Chadbourn Township line, thence following the Whiteville/Chadbourn Township line~~  
11 ~~in a southeasterly direction~~ the centerline of State Highway 1435, thence following the  
12 centerline of State Highway 1435 in a southerly direction across State Highway 1436 to  
13 the centerline of State Highway 1429, thence along State Highway 1429 in an easterly  
14 direction to the centerline of State Highway 1437, thence following the boundary  
15 between State House Districts 14 and 98 as they existed on June 1, 1996, along: State  
16 Highway 1437, Pinelog Swamp and Soules Swamp to the point where Soules Swamp  
17 intersected the corporate limits of the Town of Whiteville on January 1, 1990, thence  
18 following the corporate limits of the Town of Whiteville as they existed on January 1,  
19 1990, in a generally northerly direction to the point and place of beginning.

20 Beginning at the point where the centerline of US Highway 701 Bypass intersected  
21 the southern corporate limits of the Town of Whiteville on January 1, 1990, thence  
22 following the boundary between State House Districts 14 and 98 as they existed on June  
23 1, 1996, along: US Highway 701, State Highway 1166, State Highway ~~1174 (Prison Camp~~  
24 ~~Road), 1174,~~ the corporate limits of the Town of Brunswick as they existed on January 1,  
25 1990, the boundary of Census Blocks 121B/126C and 122B/126C of Census Tract 9910,  
26 the corporate limits of the Town of Brunswick as they existed on January 1, 1990, Main  
27 Street (State Highway 130), and the Whiteville/Lees Township line easterly to the eastern  
28 boundary of the Whiteville City School Administrative Unit; thence in a northerly  
29 direction along the boundary of the Whiteville City School Administrative Unit to the  
30 centerline of US Highway 74 Business, thence westerly along the centerline of US  
31 Highway 74 Business to the intersection with the boundary of District 1, thence following  
32 the southern boundary of District 1 to the intersection of the centerline of Maulsby Street  
33 and Virgil Street, thence following the eastern and southern boundary of Whiteville City  
34 Council District #2 as it was bounded for the 1995 municipal election, (said boundary  
35 line excluding any territory not in the city limits as of January 1, 1990) to the point and  
36 place of beginning.

37 District 3 consists of all of the Whiteville City School Administrative Unit located  
38 north of US Highway 74 Business not in District 1, and also includes the following  
39 described area:

40 Beginning at the point where the centerline of US Highway 74 Business intersects the  
41 ~~Whiteville/Chadbourn Township line, thence following the Township line in a~~  
42 ~~southeasterly direction to the centerline of State Highway 1437, thence following the~~  
43 ~~centerline of State Highway 1437 in a southwesterly direction~~ centerline of State

1 Highway 1435, thence following the centerline of State Highway 1435 in a southerly  
2 direction across State Highway 1436 to the intersection with the centerline of State  
3 Highway 1429, thence following the centerline of State Highway 1429 westerly to the  
4 boundary of the Whiteville City School Administrative Unit, thence in a northerly  
5 direction along the boundary of the Whiteville City School Administrative Unit to the  
6 centerline of US Highway 74 Business, thence following the centerline of US Highway  
7 74 Business in an easterly direction to the point and place of beginning.

8 District 4 consists of all the area of the Whiteville City School Administrative Unit  
9 South of US Highway 74 Business which is not in any other district."

10 Section 4. This act is effective when it becomes law.
