## HOUSE BILL DRH30368-BEz-9

Short Title: Study Career/Coll. Read. in Perf. Grades. (Public) Sponsors: Representatives Blackwell, Clemmons, Horn, and Hardister (Primary Sponsors). Referred to:

1	A BILL TO BE ENTITLED
2	AN ACT TO STUDY THE INCLUSION OF CAREER AND COLLEGE READINESS
3	COURSEWORK IN THE CALCULATION OF SCHOOL PERFORMANCE GRADES
4	FOR HIGH SCHOOLS.
5	The General Assembly of North Carolina enacts:
6	SECTION 1. There is established the Joint Legislative Study Committee on the
7 8	Inclusion of Career and College Readiness Coursework in School Performance Grades (Committee). The Committee shall consist of three members of the Senate appointed by the
8 9	President Pro Tempore of the Senate and three members of the House of Representatives
9 10	appointed by the Speaker of the House of Representatives. The President Pro Tempore of the
10	Senate and the Speaker of the House of the Representatives shall each appoint a cochair of the
11	Committee from among its membership. Members shall serve at the pleasure of the appointing
12	officer.
13 14	<b>SECTION 2.</b> The Committee shall study and make recommendations on the
15	following:
16	(1) Different ways to include in high school performance grades the participation
17	and success in coursework that results in credit toward (i) college graduation
18	(such as dual enrollment, AP, or IB courses) or (ii) a valuable postsecondary
19	credential or certification recognized by one or more nationally recognized
20	business groups.
20	(2) How other states have incorporated the coursework described in subdivision
22	(1) of this section into their school evaluation systems, including a review of
23	other states' Every Student Succeeds Act (ESSA) plans.
24	(3) How various approaches for including such coursework in high school
25	performance grades would impact school performance grades across the State,
26	including sample calculations by the Department of Public Instruction.
27	(4) Any other issue the Committee considers relevant to this study.
28	<b>SECTION 3.</b> The Committee shall meet upon the call of its cochairs. A quorum of
29	the Committee is a majority of its members. No action may be taken except by a majority vote
30	at a meeting at which a quorum is present. The Committee, while in the discharge of its official
31	duties, may exercise all powers provided for under G.S. 120-19 and Article 5A of Chapter 120
32	of the General Statutes. The Committee may contract for professional, clerical, or consultant
33	services, as provided by G.S. 120-32.02. Members of the Committee shall receive per diem,
34	subsistence, and travel allowance as provided in G.S. 120-3.1. The expenses of the Committee
35	shall be considered expenses incurred for the joint operation of the General Assembly.

SECTION 4. The Legislative Services Officer shall assign professional and clerical 1 2 staff to assist the Committee in its work. The Director of Legislative Assistants of the House of 3 Representatives and the Director of Legislative Assistants of the Senate shall assign clerical 4 support to staff the Committee. 5 **SECTION 5.** The Committee shall submit a final report on the results of its study, 6 including any proposed legislation, to the members of the Senate and the House of 7 Representatives on or before April 1, 2020, by filing a copy of the report with the Office of the 8 President Pro Tempore of the Senate, the Office of the Speaker of the House of Representatives, 9 the Joint Legislative Education Oversight Committee, and the Legislative Library. The 10 Committee shall terminate on April 1, 2020, or upon the filing of its final report, whichever 11 occurs first.

- **SECTION 6.** This act is effective when it becomes law.
