The Commission shall 3 not provide for more than 12-13 paid holidays per year, with three paid 4 holidays being given for Christmas. 5 (5a) In years in which New Year's Day falls on Saturday, the Commission may 6 designate December 31 of the previous calendar year as the New Year's 7 holiday, provided that the number of holidays for the previous calendar year 8 does not exceed 12-13 and the number of holidays for the current year does 9 not exceed 10.11. When New Year's Day falls on either Saturday or Sunday. the constituent institutions of The University of North Carolina that adopt 10 11 alternative dates to recognize the legal public holidays set forth in subdivision (5) of this section and established by the Commission may designate, in 12 13 accordance with the rules of the Commission and the requirements of this 14 subdivision, December 31 of the previous calendar year as the New Year's 15 holiday. 16 17

The policies and rules of the Commission shall not limit the power of any elected or appointed department head, in the department head's discretion and upon the department head's determination that it is in the best interest of the Department, to transfer, demote, or separate a State employee who is not a career State employee as defined by this Chapter."

SECTION 3. This act is effective when it becomes law.
