FISCAL IMPACT SUMMARY

Fiscal Research estimates that the costs to AOC would be \$2,097,409 annually from the changes in this bill, assuming a standard range of days served over a similar number of jurors as in FY 2017-18.

FISCAL ANALYSIS

Section 1 of the bill would amend G.S. 7A-312(a) to increase the rate of pay for jurors from \$12 to \$20 for the first day of service, from \$20 to \$30 for each day after that, and from \$40 to \$50 for each day in excess of five days. The section would also increase the rate of pay for grand jurors from \$20 to \$30.

The Administrative Office of the Courts (AOC) estimates jury costs based on an estimated empaneled jury pool of 30 for the first day and a 12-person jury plus two alternates for subsequent days. For criminal cases, jury costs come to \$360 per day for the first day, \$280 per day for the second through the fifth, and \$560 per day for service beyond five days. Grand jurors are paid \$20 per day, regardless of the number of days served.

The changes in this bill would increase criminal case jury costs to \$600 for day one, \$420 for days two to five, and \$700 for days over five. Grand jurors would be paid \$30 per day.

In FY 2017-18, AOC paid 155,679 individuals to serve as jurors at an average cost of \$24.67 per person. As this bill would increase the average pay by 54.6%, if the same number of individuals serve as jurors going forward, the average pay would be \$38.14 per person. This leads to an annual increase in costs of \$2,097,409 to AOC.
