5	(d) This section does not apply to insurers licensed under Chapter 58 of the General		
6	Statutes, or to banks, trust companies, savings and loan associations, savings banks, or credit		
7	unions licensed or organized under the laws of any state or the United States, or any foreign bank		
8	maintaining a branch or agency licensed under the laws of the United States, or any subsidiary		
9	or affiliate thereof, nor does this section apply to any entity subject to regulation by the Federal		
10	Communications Commission under Title 47 of the United States Code or by the North Carolina		
11	Utilities Commission under Chapter 62 of the General Statutes, or to any entity doing business		
12	directly or through an affiliate pursuant to a franchise, license, certificate, or other authorization

18	notice to the seller of the consumer's intention to terminate the contract."		
19	<b>SECTION 2.</b> This act becomes effective January 1, 2022, and applies to contracts		
20	entered into on or after that date.
