10	SECTION 1. Any local board of education that installs a solar energy system in a			
11	school facility that qualifies as a small power producer, as that term is defined under G.S. 62-3,			
12	shall be eligible for purchased power rates and terms, including a contract duration of 10 years,			
13	under Purchased Power Schedule PP-1 from an electric public utility, notwithstanding any order			
14	of the North Carolina Utilities Commission, including any provision of the Order Establishing			
15	Standard Rates and Contract Terms for Qualifying Facilities issued by the North Carolina			
16	Utilities Commission on October 11, 2017, in the matter of Biennial Determination of Avoided			
17	Cost Rates for Electric Utility Purchases from Qualifying Facilities – 2016, Docket No. E-100,

19	SE	ECTION 2. This act is effective when it becomes law and applies to any local boa	ırd	
20	of education that installs a solar energy system on a school facility on or before that date, and			
21	has, on or before that date, done all of the following:			
22	(1)) Filed a report of proposed construction (ROPC) or Certificate of Pub	lic	
23		Convenience and Necessity (CPCN) application for construction of t	he	
24		facility, as applicable.		
25	(2)) Submitted a completed interconnection request pursuant to the North Caroli	na	
26		Interconnection Procedures (NCIP).		
27	(3)) Certified as a Qualifying Facility with the Federal Energy Regulate	ry	
28		Commission (FERC), if greater than 1 MW.
