REVISE NORTH CAROLINA PRINCIPAL FELLOWS COMMISSION 18 **MEMBERSHIP** 19 **SECTION 3.(a)** G.S. 116-74.41 reads as rewritten: 20 "§ 116-74.41. North Carolina Principal Fellows Commission established; membership. 21 There is established the North Carolina Principal Fellows Commission. The 22 Commission shall exercise its powers and duties independently in its administration of the North 23 Carolina Principal Fellows Program in accordance with this Article. The Director of the Program 24 shall staff the Commission in accordance with G.S. 116-74.49. The State Education Assistance 25 Authority as created in G.S. 116-203 shall be responsible for awarding grants upon selection of 26 the recipients by the Commission in accordance with G.S. 116-74.46 and executing agreements 27 for forgivable scholarship loans, cancelling through service, collecting, and otherwise enforcing 28 the agreements under G.S. 116-74.48. 29 Repealed by Session Laws 2018-5, s. 10A.3(a), effective July 1, 2018.  - (14) The President and Chief Executive Officer of North Carolina Business Leaders for Education (BEST NC) or his or her designee.
 - (15) The President of the North Carolina Independent Colleges and Universities, or his or her designee.
 - (c) All appointments to the Commission shall be for four-year terms.
 - (d) Except as otherwise provided, if a vacancy occurs in the membership, the appointing authority shall appoint another person to serve for the balance of the unexpired term. In the discretion of the appointing authority, a State Board of Education member or a member of the Board of Governors of The University of North Carolina may complete a term on the Commission after the member's appointment from the appointing board has expired.
 - (e) Commission members shall receive per diem, subsistence, and travel allowances in accordance with G.S. 138-5 or G.S. 138-6, as appropriate.
 - (f) The initial meeting of the Commission shall be called by the member of the Board of Governors of The University of North Carolina appointed under subdivision (1) of subsection (b) of this section and the director shall be appointed by the Commission at the initial meeting. Thereafter, the Commission shall meet regularly, at times and places deemed necessary by the chair."
 - **SECTION 3.(b)** The new member of the North Carolina Principal Fellows Commission, created in accordance with G.S. 116-74.41(b)(15), as enacted by this section, shall begin his or her term on July 1, 2023.

PART IV. CLARIFICATION ON CURRICULUM

SECTION 4. The Beaufort County Board of Education in implementing the standard course of study, as established by Article 8 of Chapter 115C of the General Statutes, may use the Hillsdale College K-12 Curriculum to the extent that Curriculum does not conflict with requirements of the standard course of study.

PART V. RAISE THE DAILY DEPOSIT LIMIT FOR PUBLIC SCHOOLS

SECTION 5. G.S. 115C-445 reads as rewritten:

"§ 115C-445. Daily deposits.

Except as otherwise provided by law, all moneys collected or received by an officer, employee or agent of a local school administrative unit or an individual school shall be deposited in accordance with this section. Each officer, employee and agent of a local school administrative unit or individual school whose duty it is to collect or receive any taxes or other moneys shall deposit his collections and receipts daily. If the board of education gives its approval, deposits shall be required only when the moneys on hand amount to as much as two hundred fifty dollars (\$250.00), one thousand five hundred dollars (\$1,500), but in any event a deposit shall be made on the last business day of the month. All deposits shall be made with the finance officer or in an official depository. Deposits in an official depository shall be immediately reported to the finance officer or individual school treasurer by means of a duplicate deposit ticket. The finance officer may at any time audit the accounts of any officer, employee or agent collecting or receiving any taxes or other moneys, and may prescribe the form and detail of these accounts. The accounts of such an officer, employee or agent shall be audited at least annually."

PART VI. EFFECTIVE DATE

SECTION 6. This act is effective when it becomes law.
