2	AN ACT TO ESTABLISH THE NORTH CAROLINA SEMIQUINCENTENNIAL
3	LEGISLATIVE COMMISSION.
4	The General Assembly of North Carolina enacts:
5	SECTION 1.(a) There is established the North Carolina Semiquincentennial
6	Legislative Commission (Commission). The purpose of the Commission is to participate in the
7	planning for the observance of the semiquincentennial of the American Revolution in North
8	Carolina. The Commission shall coordinate with the North Carolina USA 250th Committee and
9	the Department of Natural and Cultural Resources to make recommendations for the observance
10	of the semiquincentennial of the American Revolution in North Carolina. Recommendations
11	shall include any proposed legislation or appropriation appropriate to carry out the
12	recommendations.
13	SECTION 1.(b) The Commission shall consist of eight members as follows:
14	(1) Four members of the Senate appointed by the President Pro Tempore of the

4 **SECTION 1.(f)** The Commission shall submit interim reports by December 1 5 annually, beginning with December 1, 2023, to the cochairs of the Appropriations/Base Budget 6 Committee of the Senate and the cochairs of the Appropriations Committee of the House of 7 Representatives. The Commission shall submit a final report no later than April 15, 2031. The

- 8 Commission shall terminate upon the earlier of April 15, 2031, or submission of the report.
