



1 "Section 3.2. Composition of Town Board. The Board shall consist of five commissioners,  
2 each to be elected at large by the qualified voters of the Town in the manner provided in Article  
3 IV of this Charter.

4 "Section 3.3. Mayor. The Mayor shall be elected by the qualified voters of the Town voting  
5 at large in the manner provided in Article IV of this Charter. The Mayor shall be the official head  
6 of the Town government and shall preside at all meetings of the Board. The Mayor shall vote  
7 only in the case of a tie.

8 "Section 3.4. Mayor Pro Tempore. In accordance with general law, the Board shall elect one  
9 of its members to act as Mayor Pro Tempore to perform the duties of the Mayor during the  
10 Mayor's absence.

11 "Section 3.5. Terms and Vacancies. Members of the Board shall serve staggered four-year  
12 terms with three members elected in the same election every four years and two members and  
13 the Mayor elected in the same election two years thereafter. The Mayor shall serve a four-year  
14 term. Vacancies that occur in any elective office of the Town shall be filled in accordance with  
15 G.S. 160A-63.

16 "Section 3.6. Meetings. In accordance with general law, the Board shall establish a suitable  
17 time and place for its regular meetings. Special and emergency meetings may be held as provided  
18 by general law. Official actions of the Board and all votes shall be taken in accordance with the  
19 applicable provisions of general law.

#### 20 "ARTICLE IV. ELECTIONS.

21 "Section 4.1. Regular Municipal Elections. Regular municipal elections shall be held in each  
22 odd-numbered year in accordance with the uniform municipal election laws of North Carolina.  
23 The election of members of the Board and the Mayor shall be conducted on a nonpartisan basis,  
24 and the results determined using the nonpartisan plurality method as provided by G.S. 163-292.

#### 25 "ARTICLE V. ORGANIZATION AND ADMINISTRATION.

26 "Section 5.1. Form of Government. The Town shall operate under the council-manager form  
27 of government in accordance with Part 2 of Article 7 of Chapter 160A of the General Statutes.

28 "Section 5.2. Town Manager. The Board shall appoint a Town Manager to serve at its  
29 pleasure who shall be the chief administrative official of Town government, and who shall be  
30 responsible to the Board for the proper administration of the affairs of the Town. The Town  
31 Manager shall have those powers and duties provided by general law. In addition, the Town  
32 Manager shall appoint the Town Clerk, Finance Officer, Tax Collector, and Chief of Police and  
33 may create new positions or departments or assign additional functions to offices, positions, or  
34 departments as provided by general law.

35 "Section 5.3. Town Attorney. The Board shall appoint a Town Attorney who shall represent  
36 the Town, advise Town officials, and perform other duties required by law or as the Board may  
37 direct.

#### 38 "ARTICLE VI. SPECIAL POWERS AND MISCELLANEOUS PROVISIONS.

39 "Section 6.1. Extraterritorial Jurisdiction. Notwithstanding the provisions of G.S. 160D-202,  
40 the Town may exercise the powers granted under Chapter 160D of the General Statutes within a  
41 defined area extending not more than two miles beyond its contiguous corporate limits so long  
42 as the defined area is not within the corporate limits of another town or city.

43 "Section 6.2. Assessments for Transportation Improvements. The Town, acting in  
44 accordance with all other procedures of Article 10 of Chapter 160A of the General Statutes, shall  
45 have the power to levy special assessments for street or sidewalk improvements without receiving  
46 a petition as required in G.S. 160A-217(a).

47 "Section 6.3. Authority to Survey and Plat for Transportation Improvements. The Town shall  
48 have power to request, make, or cause to be made, from time to time, surveys for the exact  
49 locating of the lines of new, extended, widened, or narrowed streets, highways, or other  
50 transportation facilities in the whole or any portion of the Town and the area within its  
51 extraterritorial planning jurisdiction. Personnel making such surveys are empowered to enter

1 upon lands, make examinations or surveys, and place and maintain necessary monuments  
2 thereon, at reasonable times and with due care for the property. A plat or plats of the area or areas  
3 thus surveyed shall be prepared, on which are indicated the locations of the lines recommended  
4 as the planned or mapped lines of future rights-of-way or changes to the right-of-way. The  
5 preparation of such plat or plats shall not in and of itself constitute or be deemed to constitute the  
6 opening or establishment of any streets or the taking or acceptance of any land for street purposes.

7 "Section 6.4. Recreation Fees in Lieu. In addition to the authority granted in Article 8 of  
8 Chapter 160D of the General Statutes, the Town, in the exercise of its powers to regulate the  
9 subdivision of land subject to its jurisdiction, is authorized to determine the amount of funds to  
10 be paid as a fee in lieu of dedication of land for recreation, park, or open space sites, by using a  
11 formula based upon a charge per dwelling unit of the development or subdivision without  
12 reference to property tax value; provided that this charge may vary depending on the size or type  
13 of the dwelling unit and that such fee in lieu may not exceed the fair market value of the land  
14 area that would have otherwise been required to be dedicated. Such fees in lieu shall be used for  
15 the acquisition or development of recreation, park, or open space sites that are reasonably  
16 expected to benefit or serve residents of the development or subdivision and may also be used  
17 toward acquisition or development of recreation facilities that benefit residents of the Town  
18 beyond the immediate area of the subdivision or development.

19 "Section 6.5. Billing and Collection of Public Enterprise Fees. The Town may adopt an  
20 ordinance providing that any fee imposed in connection with the operation of a public enterprise  
21 authorized by general law may be billed with property taxes, may be payable in the same manner  
22 as property taxes, and, in the case of nonpayment, may be collected in any manner by which  
23 delinquent personal or real property taxes can be collected. If an ordinance states that delinquent  
24 fees can be collected in the same manner as delinquent real property taxes, the fees shall be a lien  
25 on the real property described in the bill that includes the fees.

26 "Section 6.6. Acceptance of Conveyance of Real Property for Liens. Notwithstanding any  
27 applicable provisions of general law, the Town Board, by resolution, may accept conveyance of  
28 real property on which the Town has a lien, in full or partial satisfaction of the tax, special  
29 assessment, or other charge or liability underlying the lien, including the expense of transferring  
30 title to the Town. The resolution shall order the lien cancelled of record or reduced to the extent  
31 the liability underlying the lien is satisfied. Acceptance of conveyance by the Town does not  
32 affect a lien on the property held by a person or entity other than the Town. Property conveyed  
33 to the Town under this section may be disposed of subsequently by the Town under any of the  
34 methods authorized by law."

35 **SECTION 2.** The purpose of this act is to revise the Charter of the Town of  
36 Youngsville and to consolidate certain acts concerning the property, affairs, and government of  
37 the Town. It is intended to continue without interruption those provisions of prior acts that are  
38 expressly consolidated into this act and those provisions of prior acts which are not inconsistent  
39 with the foregoing so that all rights and liabilities which have accrued are preserved and may be  
40 enforced.

41 **SECTION 3.** This act does not repeal or affect any acts concerning the property,  
42 affairs, or government of public schools or any acts validating official actions, proceedings,  
43 contracts, or obligations of any kind.

44 **SECTION 4.** The following acts, having served the purposes for which they were  
45 enacted or having been consolidated into this act, are expressly repealed:

3 **SECTION 5.** This act does not affect any rights or interests that arose under any  
4 provisions repealed by this act.

5 **SECTION 6.** All existing ordinances, resolutions, and other provisions of the Town  
6 of Youngsville not inconsistent with the provisions of this act shall continue in effect until  
7 repealed or amended.

8 **SECTION 7.** Whenever a reference is made in this act to a particular provision of  
9 the General Statutes and such provision is later amended, superseded, or recodified, the reference  
10 shall be deemed amended to refer to the amended General Statute or to the General Statute that  
11 most clearly corresponds to the statutory provision that is superseded or recodified.

12 **SECTION 8.** If any provision of this act or application thereof is held invalid, such  
13 invalidity shall not affect other provisions or applications of this act that can be given effect  
14 without the invalid provision or application and, to this end, the provisions of this act are declared  
15 to be severable.

16 **SECTION 9.** In order to stagger the terms of the Board and Mayor of the Town, as  
17 provided in Section 3.5 of the Charter of the Town of Youngsville, as enacted by Section 1 of  
18 this act, the term of the current Mayor of the Town shall be extended for two years and shall expire  
19 in 2027.

20 **SECTION 10.** This act is effective when it becomes law.
