- **SECTION 2.** This act has no effect upon the validity of any liens of the Town of Fuquay-Varina for ad valorem taxes or special assessments outstanding before the effective date of this act. Such liens may be collected or foreclosed upon after the effective date of this act as though the property were still within the corporate limits of the Town of Fuquay-Varina.
- SECTION 3. This act becomes effective June 30, 2023. Property in the territory described in Section 1 of this act as of January 1, 2023, is no longer subject to municipal taxes for taxes imposed for taxable years beginning on or after July 1, 2023.
