2	values and outcomes are drivers of State policy and work to engage knowledgeable individuals
3	who have experienced mental health recovery and external experts to inform the Division of

19	of Article 3 of Chapter 143B of the General Statutes, as enacted by subsection (b) of this section.
20	SECTION 2.(d) There is appropriated from the General Fund to the Department of
21	Health and Human Services, Division of Mental Health, Developmental Disabilities, and
22	Substance Abuse Services (DMH/DD/SAS), the sum of one hundred thousand dollars (\$100,000)
23	in recurring funds for the 2023-2024 fiscal year and the sum of one hundred thousand dollars
24	(\$100,000) in recurring funds for the 2024-2025 fiscal year to be used to fund the salary and
25	benefits for the Mental Health Recovery Policy Chief position within DMH/DD/SAS, required
26	under G.S. 143B-216.90, as enacted by subsection (b) of this section.
27	SECTION 3. This act becomes effective July 1, 2023.
