A BILL TO BE ENTITLED AN ACT TO ENACT PROVISIONS RELATED TO IMPROVING THE NUMBER AND QUALITY OF SCHOOL PSYCHOLOGISTS IN NORTH CAROLINA. The General Assembly of North Carolina enacts:		
PART I. INCREASE COMPENSATION FOR SCHOOL PSYCHOLOGISTS SECTION 1.(a) For the 2023-2024 fiscal year, in addition to any salary received		
under the teacher salary schedule, school psychologists shall receive the following salary supplements:		
(1) (2)	School psychologists who have a Nationally Certified School (NCSP) credential shall receive a salary supplement each me percent (12%) of their monthly salary.	nonth of twelve
SECTION 1.(b) There is appropriated from the General Fund to the Department of Public Instruction for the 2023-2024 fiscal year the sum of eight million one hundred thousand dollars (\$8,100,000) in recurring funds to provide compensation increases for school psychologists pursuant to this section.

- Award of funds. The Superintendent of Public Instruction shall award grants 1 (3) 2 to public school units to provide signing bonuses to recruit school 3 psychologists, as follows: 4 The Department shall prioritize the award of funds to public school 5
 - units that do not employ a full-time school psychologist at the time the application is submitted.
 - No individual bonus shall be greater than five thousand dollars <u>b.</u> (\$5,000).
 - As a condition of accepting a signing bonus, a school psychologist <u>c.</u> shall agree to remain employed in the public school unit for at least one year.
 - <u>d.</u> Grants provided to public school units pursuant to the Program shall be used to supplement and not to supplant State or non-State funds already provided for these services.
 - Report. No later than April 1, 2024, and each subsequent year thereafter in which (b) funds allocated pursuant to this section are awarded, the Superintendent of Public Instruction shall report on the Program to the Joint Legislative Education Oversight Committee and the Fiscal Research Division. The report shall include the identity of each public school unit that received a grant through the Program, the amount of funding provided to the public school unit, and the use of funds by the public school unit."

SECTION 2.(b) Appropriation. – There is appropriated from the General Fund to the Department of Public Instruction for the 2023-2024 fiscal year the sum of one million seven hundred thousand dollars (\$1,700,000) in recurring funds to establish and implement the School Psychologists Grant Program pursuant to G.S. 115C-316.6, as enacted by this act.

PART III. SCHOOL PSYCHOLOGISTS RECRUITMENT AND RETENTION COORDINATOR

SECTION 3. No later than September 1, 2023, the Department of Public Instruction shall permanently reclassify at least one position within the Department to serve as a full-time recruitment and retention coordinator to increase the number of school psychologists in public school units that have a demonstrated need that is difficult to fill. The job duties for this position shall include effectively recruiting school psychologists to North Carolina from other states with a surplus of trained school psychologists.

PART IV. SCHOOL PSYCHOLOGISTS INTERNSHIP PROGRAM

SECTION 4.(a) Article 21 of Chapter 115C of the General Statutes is amended by adding a new section to read:

"§ 115C-316.7. School psychologists internship program.

- The Department of Public Instruction shall establish an internship program for school psychologists in public school units. Participants in an approved full-time school psychology preparation program shall receive up to a 10-month stipend during the internship period of the program. The stipend shall be at the beginning salary of a school psychologist. The school psychology preparation program where the intern is enrolled shall provide the Department of Public Instruction with certification that the intern is an eligible full-time student.
- Field supervisors in public school units providing instruction to school psychology interns receiving stipends in accordance with this section shall be eligible to receive one lump sum salary supplement of between five hundred dollars (\$500.00) and one thousand two hundred dollars (\$1,200) in an amount to be determined by the public school unit."

SECTION 4.(b) There is appropriated from the General Fund to the Department of Public Instruction the sum of five million dollars (\$5,000,000) in recurring funds to establish and

PART V. FUNDS FOR A VIRTUAL SCHOOL PSYCHOLOGY TRAINING PROGRAM

SECTION 5. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina for the 2023-2024 fiscal year the sum of five million dollars (\$5,000,000) in nonrecurring funds to be allocated to Appalachian State University (ASU) to host a virtual school psychology training program at the ASU campus in Hickory, North Carolina.

PART VI. INCREASE FUNDS FOR SCHOOL PSYCHOLOGIST TRAINING PROGRAMS

SECTION 6. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of one million six hundred thousand dollars (\$1,600,000) in recurring funds for the 2023-2024 fiscal year to be allocated to the following constituent institutions of The University of North Carolina to support the school psychology programs at those institutions with the goal of doubling the number of school psychologists produced:
