Short Title: Build Safer Communities and Schools Act. (Public)

A BILL TO BE ENTITLED

AN ACT TO STRENGTHEN POLICIES AND STANDARDS SURROUNDING LAW ENFORCEMENT OFFICERS; TO APPROPRIATE FUNDS TO CREATE THE N.C. STAR PILOT PROGRAM TO PROVIDE GRANTS TO CITY AND TOWN POLICE DEPARTMENTS TO CREATE LOCAL SUPPORT TEAM ASSISTED RESPONSE (STAR) PILOT PROGRAMS; TO REINSTATE THE PISTOL PURCHASE PERMIT REQUIREMENT TO PURCHASE A PISTOL FOR PRIVATE SALES AND MAKE THE STATE BUREAU OF INVESTIGATION RESPONSIBLE FOR PERMITS; TO REQUIRE UNIVERSAL BACKGROUND CHECKS; TO STRENGTHEN SAFE STORAGE OF FIREARMS LAWS; TO PROVIDE A SALES TAX EXEMPTION FOR EQUIPMENT DESIGNED TO PREVENT UNAUTHORIZED PERSONS FROM ACCESSING FIREARMS; TO AUTHORIZE THE ISSUANCE OF AN EXTREME RISK PROTECTION ORDER TO RESTRICT TEMPORARILY A PERSON'S ACCESS TO FIREARMS IF THERE IS EVIDENCE THAT THE PERSON POSES A DANGER OF PHYSICAL HARM TO SELF OR OTHERS; TO ALLOW SCHOOLS TO CONTRACT FOR SCHOOL PSYCHOLOGIST SERVICES; AND TO CODIFY SCHOOL SAFETY GRANTS.

The General Assembly of North Carolina enacts:

**PART I. STRENGTHEN POLICIES AND STANDARDS SURROUNDING LAW ENFORCEMENT OFFICERS; CREATE LOCAL SUPPORT TEAM ASSISTED RESPONSE PILOT PROGRAMS**

**DIRECT THE DEPARTMENT OF JUSTICE TO ASSIST LAW ENFORCEMENT AGENCIES IN APPLYING FOR GRANT FUNDS AND FUND POSITIONS TO MEET THE REQUIREMENTS OF THIS SECTION**

**SECTION 1.1.(a)** The Department of Justice shall provide assistance to law enforcement agencies seeking grant funds, including, but not limited to, the following:

- (1) Alerting law enforcement agencies to available grant funds.
- (2) Assisting law enforcement agencies with drafting and submitting grant proposals and applications.

**SECTION 1.1.(b)** There is appropriated from the General Fund to the Department of Justice the sum of two hundred thousand dollars (\$200,000) in recurring funds for each year of the 2023-2025 fiscal biennium to be used to hire two full-time grant writers to assist law enforcement agencies pursuant to the requirements of subsection (a) of this section.

**SECTION 1.1.(c)** This section becomes effective July 1, 2023.

**SUPPORT COMMUNITY POLICING PROGRAMS**

**SECTION 1.2.(a)** There is appropriated from the General Fund to the Department of Justice the sum of two hundred fifty thousand dollars (\$250,000) in recurring funds for each year of the 2023-2025 fiscal biennium to be used to award grants to law enforcement agencies for initiatives supporting community policing.

**SECTION 1.2.(b)** This section becomes effective July 1, 2023.

**CREATE INCENTIVES FOR LAW ENFORCEMENT OFFICERS AND AGENCIES**

**SECTION 1.3.(a)** There is appropriated from the General Fund to the Department of Justice the sum of five hundred thousand dollars (\$500,000) in recurring funds for the 2024-2025 fiscal year to be used to provide the following types of grants:

- (1) Grants provided to law enforcement agencies to be awarded to law enforcement officers exhibiting exemplary service as established by the Department of Justice.
- (2) Grants awarded to law enforcement agencies for meeting racial or gender diversity benchmarks as established by the Department of Justice.

**SECTION 1.3.(b)** No grant awarded pursuant to this section shall exceed ten thousand dollars (\$10,000).

**SECTION 1.3.(c)** This section becomes effective July 1, 2024.

**REVISE POLICE USE OF FORCE POLICIES**

**SECTION 1.4.(a)** G.S. 15A-401(d) is amended by adding a new subdivision to read:

"(3) Under all circumstances in which a law-enforcement officer uses force of any kind, a law-enforcement officer shall use the minimum amount of force reasonably necessary to accomplish the law-enforcement action and shall attempt to utilize de-escalation tactics when possible."

**SECTION 1.4.(b)** The Attorney General, in consultation with the North Carolina Sheriffs' Association and the North Carolina Association of Chiefs of Police, shall develop uniform use of force policies that may be adopted by all law enforcement agencies in the State. These policies shall be submitted to the Joint Legislative Oversight Committee on Justice and Public Safety no later than December 1, 2024, shall be published on the Department of Justice website, and shall be distributed in digital format by the Attorney General to all law enforcement agencies in the State.

**SECTION 1.4.(c)** Subsection (a) of this section becomes effective October 1, 2023, and applies to actions taken on or after that date. The remainder of this section is effective when it becomes law.

**ESTABLISH MINIMUM STANDARDS FOR THE HIRING AND TRAINING OF LAW ENFORCEMENT OFFICERS**

**SECTION 1.5.(a)** G.S. 17C-6(a) reads as rewritten:

"(a) In addition to powers conferred upon the Commission elsewhere in this Article, the Commission shall have the following powers, which shall be enforceable through its rules and regulations, certification procedures, or the provisions of G.S. 17C-10:

...

(2a) Establish the minimum age requirement that shall be met in order to qualify for entry level employment as a criminal justice officer in temporary or probationary status or in a permanent position, which shall not be less than 21 years of age.

(2b) Establish minimum mental health screening protocols that must be met in order to qualify for entry level employment and retention as a criminal justice officer in temporary or probationary status or in a permanent position. The

1 standards for entry level employment shall include a psychological screening  
2 within one year prior to certification performed by a physician, psychologist,  
3 psychiatric nurse practitioner, or other mental health professional.

4 ...

5 (17a) Establish minimum annual mental health screening protocols for criminal  
6 justice officers, including additional mental health screening protocols for  
7 criminal justice officers following a traumatic event, including a  
8 psychological screening performed by a physician, psychologist, psychiatric  
9 nurse practitioner, or other mental health professional.

10 ...."

11 **SECTION 1.5.(b)** G.S. 17C-13(b) reads as rewritten:

12 "(b) Notwithstanding G.S. 15A-145.4 or G.S. 15A-145.5, the Commission may gain  
13 access to a person's misdemeanor and felony conviction records, including those maintained by  
14 the Administrative Office of the Courts in its confidential files containing the names of persons  
15 granted expunctions. The Commission may deny, suspend, or revoke a person's certification  
16 based solely on that person's felony conviction, conviction or the conviction of four or more  
17 misdemeanors, whether or not that conviction was the convictions were expunged."

18 **SECTION 1.5.(c)** G.S. 17E-4(a) reads as rewritten:

19 "(a) The Commission shall have the following powers, duties, and responsibilities, which  
20 are enforceable through its rules and regulations, certification procedures, or the provisions of  
21 G.S. 17E-8 and G.S. 17E-9:

22 ...

23 (2a) Establish the minimum age requirement that shall be met in order to qualify  
24 for entry level employment as an officer in temporary or probationary status  
25 or in a permanent position, which shall not be less than 21 years of age.

26 (2b) Establish minimum mental health screening protocols that must be met in  
27 order to qualify for entry level employment and retention as an officer in  
28 temporary or probationary status or in a permanent position. The standards for  
29 entry level employment shall include a psychological screening within one  
30 year prior to certification performed by a physician, psychologist, psychiatric  
31 nurse practitioner, or other mental health professional.

32 ...

33 (13a) Establish minimum annual mental health screening protocols for officers,  
34 including additional mental health screening protocols for officers following  
35 a traumatic event, including a psychological screening performed by a  
36 physician, psychologist, psychiatric nurse practitioner, or other mental health  
37 professional.

38 ...

39 The Commission may certify, and no additional certification shall be required from it, programs,  
40 courses and teachers certified by the North Carolina Criminal Justice Education and Training  
41 Standards Commission. Where the Commission determines that a program, course, instructor or  
42 teacher is required for an area which is unique to the office of sheriff, the Commission may certify  
43 such program, course, instructor, or teacher under such standards and procedures as it may  
44 establish."

45 **SECTION 1.5.(d)** G.S. 17E-12(b) reads as rewritten:

46 "(b) Notwithstanding G.S. 15A-145.4 or G.S. 15A-145.5, the Commission may gain  
47 access to a person's misdemeanor and felony conviction records, including those maintained by  
48 the Administrative Office of the Courts in its confidential files containing the names of persons  
49 granted expunctions. The Commission may deny, suspend, or revoke a person's certification  
50 based solely on that person's felony conviction, conviction or the conviction of four or more  
51 misdemeanors, whether or not that conviction was the convictions were expunged."

1           **SECTION 1.5.(e)** There is appropriated from the General Fund to the Department  
2 of Justice the sum of one million dollars (\$1,000,000) in recurring funds for each year of the  
3 2023-2025 fiscal biennium to be used to provide grants to law enforcement agencies to pay for  
4 the mental health screenings required by subsections (a) and (c) of this section.

5           **SECTION 1.5.(f)** Subsections (a) and (c) of this section become effective January  
6 1, 2024, and apply to officers hired or employed on or after that date. Subsections (b) and (d) of  
7 this section become effective January 1, 2024, and apply to (i) officers hired on or after that date  
8 and (ii) officers employed on or after that date that are convicted of a felony or misdemeanor on  
9 or after that date. Subsection (e) of this section becomes effective July 1, 2023. The remainder  
10 of this section is effective when it becomes law.

11  
12 **FUND ADDITIONAL DETECTIVES OR INVESTIGATIVE OFFICERS TO**  
13 **INVESTIGATE SEVERE CRIMES**

14           **SECTION 1.6.(a)** There is appropriated from the General Fund to the Department  
15 of Justice the sum of one million dollars (\$1,000,000) in recurring funds for each year of the  
16 2023-2025 fiscal biennium to be used to provide grants to law enforcement agencies to  
17 temporarily provide partial or total funding for detective or other investigative law enforcement  
18 positions in order to aid in the investigation of severe crimes that would constitute a charge of a  
19 Class D felony or higher.

20           **SECTION 1.6.(b)** This section becomes effective July 1, 2023.

21  
22 **FUNDS FOR NORTH CAROLINA JUSTICE ACADEMY**

23           **SECTION 1.7.(a)** There is appropriated from the General Fund to the North Carolina  
24 Justice Academy the sum of two hundred fifty thousand dollars (\$250,000) in recurring funds for  
25 each year of the 2023-2025 fiscal biennium to be used to expand its ability to serve law  
26 enforcement agencies of the State by providing more opportunities to attend courses and  
27 trainings.

28           **SECTION 1.7.(b)** There is appropriated from the General Fund to the North Carolina  
29 Justice Academy the sum of two hundred fifty thousand dollars (\$250,000) in nonrecurring funds  
30 for each year of the 2023-2025 fiscal biennium to be used to expand the Academy's ability to  
31 offer online courses for law enforcement agencies to allow for greater statewide participation in  
32 Academy courses and training.

33           **SECTION 1.7.(c)** This section becomes effective July 1, 2023.

34  
35 **CREATE A PARTNERSHIP BETWEEN THE NORTH CAROLINA JUSTICE**  
36 **ACADEMY AND NORTH CAROLINA COMMUNITY COLLEGES**

37           **SECTION 1.8.(a)** The North Carolina Justice Academy and the North Carolina  
38 Community College System shall develop a memorandum of understanding to allow community  
39 colleges throughout the State to provide training and education to those individuals trained and  
40 educated by the North Carolina Justice Academy in order to alleviate travel time and related costs  
41 incurred by law enforcement agencies due to the limited availability of North Carolina Justice  
42 Academy training locations.

43           **SECTION 1.8.(b)** The memorandum of understanding required by subsection (a) of  
44 this section shall be submitted to the Joint Legislative Oversight Committee on Justice and Public  
45 Safety no later than October 1, 2023.

46           **SECTION 1.8.(c)** This section is effective when it becomes law.

47  
48 **FUNDS FOR THE NORTH CAROLINA LAW ENFORCEMENT ACCREDITATION**  
49 **PROGRAM**

50           **SECTION 1.9.(a)** There is appropriated from the General Fund to the Department  
51 of Justice the sum of two hundred fifty thousand dollars (\$250,000) in recurring funds for each

1 year of the 2023-2025 fiscal biennium to be used to further develop, maintain, and staff the North  
2 Carolina Law Enforcement Accreditation Program.

3 **SECTION 1.9.(b)** This section becomes effective July 1, 2023.  
4

5 **EXPAND CRIMINAL JUSTICE FELLOWS PROGRAM**

6 **SECTION 1.10.(a)** Article 2 of Chapter 17C of the General Statutes reads as  
7 rewritten:

8 "Article 2.

9 "North Carolina Criminal Justice Fellows Program.

10 **"§ 17C-20. Definitions.**

11 As used in this Article, the following definitions apply:

12 ...

13 (5) Eligible county. – ~~A Any county with a population of less than 200,000~~  
14 ~~according to the latest federal decennial census of this State.~~

15 ...

16 **"§ 17C-22. North Carolina Criminal Justice Fellows Program established; administration.**

17 (a) Program. – There is established the North Carolina Criminal Justice Fellows Program  
18 to be administered by the Committee with the assistance of the Division. The purpose of the  
19 Program is to increase the number of criminal justice professionals by providing forgivable loans  
20 to exceptional individuals to obtain any of the following:

21 (1) An Applied Associate Degrees—Degree in Criminal Justice or other  
22 Committee-approved related fields of study as preparation to enter a criminal  
23 justice profession.

24 (2) A bachelor's degree.

25 (3) A North Carolina Basic Law Enforcement Training Program certificate of  
26 completion.

27 ...

28 (c) Awards of Forgivable Loans. – The Program shall provide forgivable loans of up to  
29 three thousand one hundred fifty-two dollars (\$3,152.00) per year for up to ~~two~~ four years to  
30 selected individuals. The funds from the forgivable loans may be used for tuition, fees, and the  
31 cost of books. The Committee may determine the maximum amount of loan proceeds that may  
32 be applied to community college ~~fees—fees, college or university fees,~~ Basic Law Enforcement  
33 Training Program fees, and course textbooks. The number of forgivable loans awarded annually  
34 shall not exceed 100 and the total number of recipients in the Program each year shall not exceed  
35 200. The Committee shall select recipients no later than June 1 of each year.

36 ...

37 (g) Administration of Forgivable Loan Awards. – Upon the naming of recipients by the  
38 Committee, the Division shall perform all administrative functions necessary to implement this  
39 Article, which functions shall include dissemination of information, disbursement, receipt,  
40 liaison with participating community colleges, colleges, universities, and Basic Law  
41 Enforcement Training Programs, determination of the acceptability of service repayment  
42 agreements, and all other functions necessary for the execution, payment, and enforcement of  
43 promissory notes required under this Article.

44 (h) Applied Associate Degree Recipient Obligations. – A recipient must become and  
45 remain a full-time student at a North Carolina community college in an Applied Associate Degree  
46 in Criminal Justice or in a Committee-approved related field of study at all times during each of  
47 the recipient's two academic years of community college study and pursue continuously studies  
48 that will qualify the recipient to be employed in an eligible criminal justice profession upon  
49 graduation. The recipient must maintain a minimum cumulative 2.0 GPA throughout the course  
50 of study and also maintain appropriate credit hours for each semester to obtain an Applied  
51 Associate Degree in Criminal Justice or Committee-approved field of study within two years.

1 The recipient must also accept employment in an eligible county in an eligible criminal justice  
2 profession for at least four out of five years following graduation. The Committee may adopt  
3 additional recipient obligations it deems appropriate.

4 (h1) Bachelor's Degree Recipient Obligations. – A recipient must become and remain a  
5 full-time student at a North Carolina college or university in a bachelor's degree and pursue  
6 continuous studies that will qualify the recipient to be employed in an eligible criminal justice  
7 profession upon graduation. The recipient must maintain a minimum cumulative 2.0 GPA  
8 throughout the course of study and also maintain appropriate credit hours for each semester to  
9 obtain a bachelor's degree within four years. The recipient must also accept employment in an  
10 eligible county as a criminal justice professional for at least four out of five years following  
11 graduation. The Committee may adopt additional recipient obligations it deems appropriate.

12 (h2) Basic Law Enforcement Training Program Certificate of Completion Recipient  
13 Obligations. – A recipient must become and remain a trainee in a North Carolina Basic Law  
14 Enforcement Training Program and pursue continuous studies that will qualify the recipient to  
15 be employed in an eligible criminal justice profession upon completion of the Basic Law  
16 Enforcement Training Program. The recipient must maintain appropriate participation and test  
17 results required to obtain a Basic Law Enforcement Training Program certificate of completion  
18 within one year. The recipient must also accept employment in an eligible county as a criminal  
19 justice professional for at least four out of five years following graduation. The Committee may  
20 adopt additional recipient obligations it deems appropriate.

21 ...

22 **"§ 17C-23. Terms of forgivable loans; receipt and disbursement of funds; default.**

23 (a) Forgivable Loans. – All forgivable loans shall be evidenced by notes made payable  
24 to the Program that bear interest at a rate not to exceed ten percent (10%) per year as set by the  
25 Committee and beginning on the first day of September after the completion of the Program or  
26 60 days after termination of the forgivable loan, whichever is earlier. The forgivable loan may  
27 be terminated upon the recipient's withdrawal from ~~school~~, a school or training program by the  
28 recipient's failure to meet the standards set by the Committee, or by the recipient's default based  
29 on conditions set by the Committee. The Committee may only disburse funds to the community  
30 ~~college~~ college, college, university, or Basic Law Enforcement Training Program where the  
31 recipient is enrolled and may not disburse funds directly to a recipient.

32 (b) Forgiveness. – The Committee shall forgive the loan and any interest accrued on the  
33 loan if, within five years after obtaining (i) an Applied Associate Degree in Criminal Justice or  
34 Committee-approved field of study, (ii) a bachelor's degree, or (iii) a Basic Law Enforcement  
35 Training Program certificate of completion, the recipient is employed on a full-time basis for a  
36 period of at least four years in an eligible county in an eligible criminal justice profession. The  
37 recipient shall provide the Committee within 60 days of completion of the Program verification  
38 of the recipient's intent to seek employment in an eligible criminal justice profession in an eligible  
39 county. The recipient shall provide verification of employment to the Committee each year until  
40 the obligation is satisfied. The Committee shall also forgive the loan if it finds that it is impossible  
41 for the recipient to meet the terms of the loan, after or before graduation, due to death or  
42 permanent disability of the recipient.

43 ...

44 (d) Repayment. – If the recipient notifies the Committee that the recipient intends to  
45 forego forgiveness of the loan after completion of the Program, the Committee shall provide the  
46 recipient with the conditions of repayment and the recipient will have 60 days to begin repayment  
47 of all funds distributed, including interest. The recipient will have up to 60 months to repay all  
48 funds distributed, including ~~interest~~ interest, received in pursuit of an Applied Associate Degree  
49 in Criminal Justice or Committee-approved field of study or a Basic Law Enforcement Training  
50 Program certificate of completion. The recipient will have up to 120 months to repay all funds  
51 distributed, including interest, received in pursuit of a bachelor's degree.

1 (e) Default. – The Committee shall determine the events that constitute a default during  
2 the Program, including, but not limited to, failure by the recipient to comply with the obligations  
3 set out in ~~G.S. 17C-22(h)~~–G.S. 17C-22(h), (h1), or (h2). In the event of default during the  
4 Program, the Committee may declare the entire unpaid amount of indebtedness evidenced by the  
5 note, including interest, immediately due and payable. A default shall preclude further  
6 participation by the recipient in the Program. Upon default, the Committee shall notify the  
7 recipient, in writing, by certified mail, return receipt requested, addressed to the recipient at the  
8 last address on file with the Committee. Refusal or nondelivery at that address will be deemed  
9 delivered after seven days. The Committee may allow a recipient who is in default to repay all  
10 funds distributed, including interest. If the Committee approves repayment, the recipient will  
11 receive the conditions of repayment and will have 60 days to begin repayment of all funds  
12 distributed, including interest. The recipient will have up to 60 months to repay all funds  
13 distributed, including ~~interest~~ interest, received in pursuit of an Applied Associate Degree in  
14 Criminal Justice or Committee-approved field of study or Basic Law Enforcement Training  
15 Program certificate of completion. The recipient will have up to 120 months to repay all funds  
16 distributed, including interest, received in pursuit of a bachelor's degree."

17 **SECTION 1.10.(b)** There is appropriated from the General Fund to the North  
18 Carolina Criminal Justice Fellows Program the sum of sixty-three thousand dollars (\$63,000) in  
19 recurring funds in each year of the 2023-2025 fiscal biennium to be used to hire one full-time  
20 loan administrator to manage and track forgivable loans distributed pursuant to the Program.

21 **SECTION 1.10.(c)** Subsection (b) of this section becomes effective July 1, 2023.  
22 The remainder of this section is effective when it becomes law and applies to North Carolina  
23 Criminal Justice Fellows Program participants selected on or after that date.  
24

## 25 ESTABLISH CRISIS INTERVENTION TEAMS

26 **SECTION 1.11.(a)** G.S. 15A-401 is amended by adding a new subsection to read:  
27 "(h) Crisis Intervention Team Requirement. – In order to assist law enforcement officers  
28 in the safe and efficient execution of the provisions of this section, all law enforcement agencies  
29 in the State shall designate specially trained law enforcement officers to be a part of an agency  
30 Crisis Intervention Team. Each Crisis Intervention Team member shall be trained in how to  
31 determine whether a person is experiencing a mental or behavioral health crisis and what methods  
32 are available to de-escalate or otherwise safely engage in interactions with a person experiencing  
33 a mental or behavioral health crisis.

34 In order to remain eligible for Governor's Crime Commission grants, all law enforcement  
35 agencies in the State shall have established a Crisis Intervention Team pursuant to this subsection  
36 no later than December 1, 2025."

37 **SECTION 1.11.(b)** There is appropriated from the General Fund to the Department  
38 of Justice the sum of two hundred fifty million dollars (\$250,000,000) in nonrecurring funds for  
39 the 2023-2024 fiscal year to provide grant funds to law enforcement agencies for Crisis  
40 Intervention Team training required by subsection (a) of this section.

41 **SECTION 1.11.(c)** Subsection (b) of this section becomes effective July 1, 2023.  
42 The remainder of this section is effective when it becomes law.  
43

## 44 CREATE GRANT FOR LOCAL SUPPORT TEAM ASSISTED RESPONSE (STAR) 45 PILOT PROGRAM

46 **SECTION 1.12.(a)** There is appropriated from the General Fund to the Criminal  
47 Justice Education and Training Standards Commission the sum of five hundred thousand dollars  
48 (\$500,000) in nonrecurring funds in the 2023-2024 fiscal year to be used to implement the N.C.  
49 STAR Pilot Program created by this section.

50 **SECTION 1.12.(b)** Grant Manager; Program. – The Criminal Justice Education and  
51 Training Standards Commission shall manage the N.C. STAR Pilot Program on behalf of the

1 State and shall develop guidelines and procedures not inconsistent with the provisions of this act  
2 for the administration of the program and distribution of program grants.

3 The N.C. STAR Pilot Program created in this act shall be created for the purpose of  
4 helping city and town police departments provide alternative responses to citizens in crisis. Each  
5 local Support Team Assisted Response (STAR) program receiving a grant under the N.C. STAR  
6 Pilot Program should allow for the response of behavioral and medical health personnel to  
7 nonviolent situations deemed appropriate by the city or town police department. At a minimum,  
8 those responding to citizens on behalf of each local STAR program should be equipped to provide  
9 individuals with information regarding shelter, food aid, counseling, and medication, as  
10 necessary.

11 **SECTION 1.12.(c) Eligible Grant Recipients.** – All city and town police departments  
12 in the State are eligible grant recipients under this section.

13 **SECTION 1.12.(d) Application for Grant Funds.** – Upon forms developed by the  
14 Criminal Justice Education and Training Standards Commission, an eligible grant recipient may  
15 apply to the Commission for the award of grant funds pursuant to this section. The application  
16 shall include, at a minimum, the following information:

- 17 (1) The city or town where the applicant department serves.
- 18 (2) Information regarding prior experience with a local STAR program or other  
19 similar program, if any.
- 20 (3) Information regarding the applicant's ability to successfully manage and

- 22 (4) The signature of the applicant's chief of police, or the chief of police's  
23 designee.

24 **SECTION 1.12.(e) Grant Determinations.** – The Criminal Justice Education and  
25 Training Standards Commission shall distribute N.C. STAR Pilot Program grant funds if it finds  
26 each of the following:

- 27 (1) The applicant is an eligible grant recipient pursuant to subsection (c) of this  
28 section.
- 29 (2) The applicant demonstrates the ability to successfully manage and implement  
30 a local STAR program.
- 31 (3) Sufficient State-allocated funds provided to the Criminal Justice Education  
32 and Training Standards Commission for the distribution of grants under the

34 **SECTION 1.12.(f) Grant Maximums.** – Grants distributed pursuant to the N.C.  
35 STAR Pilot Program shall not exceed fifty thousand dollars (\$50,000) per eligible grant recipient.

36 **SECTION 1.12.(g)** The Criminal Justice Education and Training Standards  
37 Commission may utilize up to the sum of fifty thousand dollars (\$50,000) of the funds  
38 appropriated by this act for the administration of the N.C. STAR Pilot Program.

39 **SECTION 1.12.(h)** No later than April 1 of 2024, 2025, and 2026, the Criminal  
40 Justice Education and Training Standards Commission, in consultation with each police  
41 department receiving N.C. STAR Pilot Program funds pursuant to this act, shall submit a report  
42 to the Joint Legislative Oversight Committee on Justice and Public Safety regarding the  
43 following:

- 44 (1) The general progress of each local STAR program.
- 45 (2) The number of incidents in which each police department utilized its local  
46 STAR program.
- 47 (3) The outcomes of the incidents in which each police department utilized its  
48 local STAR program.
- 49 (4) An itemized accounting from each police department of the use of N.C. STAR  
50 Pilot Program grant funds.

15           **SECTION 2.1.(a)** G.S. 14-402 is reenacted as it existed immediately prior to its  
16 repeal and reads as rewritten:

17           "**§ 14-402. Sale of certain weapons without permit forbidden.**

18           (a) It is unlawful for any ~~person, firm, or corporation~~ private person in this State to sell,  
19 give away, or transfer, or to purchase or receive, at any place within this State from any other  
20 place within or without the State any pistol from any other person other than a federally licensed  
21 firearm dealer, unless: (i) a license or permit is first obtained under this Article by the purchaser  
22 or receiver from the ~~sheriff of the county in which the purchaser or receiver resides;~~ State Bureau  
23 of Investigation; or (ii) a valid North Carolina concealed handgun permit is held under Article  
24 54B of this Chapter by the purchaser or receiver who must be a resident of the State at the time  
25 of the purchase.

26           It is unlawful for any person or persons to receive from any postmaster, postal clerk,  
27 employee in the parcel post department, rural mail carrier, express agent or employee, railroad  
28 agent or employee within the State of North Carolina any pistol without having in his or their  
29 possession and without exhibiting at the time of the delivery of the same and to the person  
30 delivering the same the permit from the ~~sheriff~~ State Bureau of Investigation as provided in  
31 ~~G.S. 14-403.~~ G.S. 14-403 or documentation demonstrating that the person is a federally licensed  
32 firearm dealer. Any person violating the provisions of this section is guilty of a Class 2  
33 misdemeanor.

34           (b) This section does not apply to an antique firearm or an historic edged weapon.

35           (c) The following definitions apply in this Article:

36           (1) Antique firearm. – Defined in G.S. 14-409.11.

37           (2), (3) Repealed by Session Laws 2011-56, s. 1, effective April 28, 2011.

38           (4) Historic edged weapon. – Defined in G.S. 14-409.12.

39           (5) through (7) Repealed by Session Laws 2011-56, s. 1, effective April 28, 2011.

40           (8) Private person. – A person, firm, or corporation who is not a federally licensed  
41 firearm dealer acting in accordance with federal law.

42           (9) Federally licensed firearm dealer. – A person who is licensed pursuant to 18  
43 U.S.C. § 923 to engage in the business of dealing in firearms."

44           **SECTION 2.1.(b)** G.S. 14-403 is reenacted as it existed immediately prior to its  
45 repeal and reads as rewritten:

22 **SECTION 2.1.(c)** G.S. 14-404 is reenacted as it existed immediately prior to its  
 23 repeal and reads as rewritten:

24 "**§ 14-404. Issuance or refusal of permit; appeal from refusal; grounds for refusal; sheriff's**  
 25 **State Bureau of Investigation's fee.**

26 (a) Upon application, and such application must be provided by the ~~sheriff~~ State Bureau

- (5) Any person who willfully fails to surrender a permit upon notice of revocation shall be guilty of a Class 2 misdemeanor.

(i) A person or entity shall promptly disclose to the ~~sheriff~~, State Bureau of Investigation, upon presentation by the applicant or ~~sheriff~~ State Bureau of Investigation of an original or photocopied release form described in subdivision (5) of subsection (e1) of this section, any court orders concerning the mental health or capacity of the applicant who signed the release form."

**SECTION 2.1.(d)** G.S. 14-405 is reenacted as it existed immediately prior to its repeal and reads as rewritten:

**"§ 14-405. Record of permits kept by ~~sheriff~~; State Bureau of Investigation; confidentiality of permit information.**

(a) The ~~sheriff~~ State Bureau of Investigation shall keep a record of all permits issued under this article, including the name, date, place of residence, age, former place of residence, etc., of each such ~~person, firm, or corporation~~ private person to whom or which a permit is issued. The record shall include the date that a permit was revoked, the date that the permittee received notice of the revocation, whether the permit was surrendered, and the reason for the revocation.

(b) The records maintained by the ~~sheriff~~ State Bureau of Investigation pursuant to this section are confidential and are not a public record under G.S. 132-1; provided, however, that the ~~sheriff~~ State Bureau of Investigation shall make the records available upon request to any federal, State, and local law enforcement agencies and shall also make the records available to the court if the records are required to be released pursuant to a court order. Any application to a court for release of the list of permit holders and permit application information shall be by a petition to the chief judge of the district court for the district in which the person seeking the information resides."

**SECTION 2.1.(e)** G.S. 14-407.1 is reenacted as it existed immediately prior to its repeal and reads as rewritten:

**"§ 14-407.1. Sale of blank cartridge pistols.**

 22 as legal or a legal transaction as illegal.

25 (b) Any person who knowingly solicits, persuades, encourages, or entices a ~~licensed~~

12                   U.S.C. § 923 to engage in the business of dealing in firearms.
- 13           (2)   Firearm. – A handgun, shotgun, or rifle which expels a projectile by action of  
14                   an explosion.
- 15           (3)   Materially false information. – Information that portrays an illegal transaction  
16                   as legal or a legal transaction as illegal.
- 17           (4)   Private person. – A person, firm, or corporation who is not a federally licensed  
18                   firearm dealer acting in accordance with federal law.

19 **"§ 14-409.50. Background checks for the sales of firearms - federally licensed firearm**  
20 **dealers.**

21           (a)   A federally licensed firearm dealer may not sell, transfer, or deliver any firearm to  
22 any private person without conducting a background check as provided for in subsection (c) of  
23 this section to verify that it would not be a violation of state or federal law for the private person  
24 to possess the firearm.

25           (b)   In addition to any other applicable state or federal law, it shall be unlawful for any of  
26 the following persons to possess a firearm:

- 27           (1)   One who is under an indictment or information for, or has been convicted in  
28                   any state or in any court of the United States of, a felony (other than an offense  
29                   pertaining to antitrust violations, unfair trade practices, or restraints of trade).
- 30           (2)   One who is a fugitive from justice.
- 31           (3)   One who is an unlawful user of or addicted to marijuana or any depressant,  
32                   stimulant, or narcotic drug (as defined in 21 U.S.C. § 802).
- 33           (4)   One who has been adjudicated mentally incompetent or has been committed  
34                   to any mental institution.
- 35           (5)   One who is an alien illegally or unlawfully in the United States.
- 36           (6)   One who has been discharged from the Armed Forces of the United States  
37                   under dishonorable conditions.
- 38           (7)   One who, having been a citizen of the United States, has renounced his or her  
39                   citizenship.
- 40           (8)   One who is subject to a court order that:
  - 41           a.   Was issued after a hearing of which the person received actual notice,  
42                   and at which the person had an opportunity to participate.
  - 43           b.   Restrains the person from harassing, stalking, or threatening an  
44                   intimate partner of the person or child of the intimate partner of the  
45                   person, or engaging in other conduct that would place an intimate  
46                   partner in reasonable fear of bodily injury to the partner or child.
  - 47           c.   Includes a finding that the person represents a credible threat to the

6 System (NICS).

7       (d) It is unlawful for a federally licensed firearm dealer to sell, transfer, or deliver any  
8 firearm to any other person if a NICS check reveals that the possession of any firearm by the  
9 person would violate state or federal law or if the federally licensed firearm dealer knows or has  
10 reason to know that the private person is prohibited from possessing any firearm by state or  
11 federal law.

12       (e) Nothing in this section prevents a transferor from removing a firearm from the  
13 premises of a licensed dealer if the results of the background check indicate that the transferee is  
14 prohibited from possessing or receiving firearms under federal or state law.

15       (f) It is a Class F felony for any federally licensed firearm dealer to sell, transfer, or  
16 deliver any firearm to any person in violation of this Article. It is a Class F felony for any person  
17 to provide any materially false information to a federally licensed firearm dealer with the intent  
18 to obtain a firearm in violation of state or federal law.

19 **"§ 14-409.51. Background checks required for the sales of firearms - private persons.**

20       (a) It shall be unlawful for a private person to transfer any firearm to any other private  
21 person without conducting a background check of that person through a federally licensed  
22 firearm dealer as provided by G.S. 14-409.50(c) and the federally licensed firearm dealer  
23 verifying that the transfer would not violate state or federal law.

24       (b) A federally licensed firearm dealer may charge a fee for conducting the background  
25 check required by subsection (a) of this section.

26       (c) For the purposes of this section, "transfer" means assigning, pledging, leasing,  
27 loaning, selling, giving away, or otherwise disposing of, but does not include any of the  
28 following:

29           (1) The loan of a firearm for any lawful purpose, for a period of 14 days or less,  
30 by the owner of the firearm to a person known personally to the owner.

31           (2) A temporary transfer for any lawful purpose that occurs while in the  
32 continuous presence of the owner of the firearm if the temporary transfer does  
33 not exceed 24 hours in duration.

34           (3) The transfer of a firearm for repair, service, or modification to a licensed  
35 gunsmith or other person lawfully engaged in such activities as a regular  
36 course of trade or business.

37           (4) A transfer that occurs by operation of law or because of the death of a person  
38 for whom the prospective transferor is an executor or administrator of an  
39 estate or a trustee of a trust created in a will.

40       (d) This section does not apply to transactions in which the private person the firearm  
41 being transferred to is a parent, mother-in-law, father-in-law, stepparent, legal guardian,  
42 grandparent, child, daughter-in-law, son-in-law, stepchild, grandchild, sibling, sister-in-law,  
43 brother-in-law, spouse, or civil union partner of the private person.

44       (e) Any violation of this section shall be punished as a Class F felony."

45       **SECTION 2.2.(b)** This section becomes effective December 1, 2023, and applies to  
46 transfers of firearms that occur on or after that date.

47  
48 **STRENGTHEN GUN STORAGE LAWS**

49       **SECTION 2.3.(a)** G.S. 14-315.1 reads as rewritten:

50 **"§ 14-315.1. ~~Storage of firearms to protect minors.~~ Safe storage of firearms.**

1 (a) Any person who resides in the same premises as a minor, owns or possesses a firearm,  
2 and stores or leaves the firearm (i) in a condition that the firearm can be discharged and (ii) in a  
3 manner that the person knew or should have known that an unsupervised minor would be able to  
4 gain access to the firearm, is guilty of a ~~Class 1 misdemeanor~~ Class D felony if a minor gains  
5 access to the firearm without the lawful permission of the minor's parents or a person having  
6 charge of the minor and the minor:

- 7 (1) Possesses it in violation of G.S. 14-269.2(b);
- 8 (2) Exhibits it in a public place in a careless, angry, or threatening manner;
- 9 (3) Causes personal injury or death with it not in self defense; or
- 10 (4) Uses it in the commission of a crime.

11 (a1) Any person who resides in the same premises as an unauthorized person, owns or  
12 possesses a firearm, and stores or leaves the firearm without having securely locked the firearm  
13 in an appropriate safe storage depository or rendered it incapable of being fired is guilty of a  
14 Class D felony if the unauthorized person gains access to the firearm and does any of the  
15 following:

- 16 (1) Possesses it in violation of G.S. 14-269.2(b).
- 17 (2) Exhibits it in a public place in a careless, angry, or threatening manner.
- 18 (3) Causes personal injury or death with it not in self defense.
- 19 (4) Uses it in the commission of a crime.

20 (b) Nothing in this section shall prohibit a person from carrying a firearm on his or her  
21 body, or placed in such close proximity that it can be used as easily and quickly as if carried on  
22 the body.

23 (c) This section shall not apply if the minor or unauthorized person obtained the firearm  
24 as a result of an unlawful entry by any person.

25 (d) The following definitions apply in this section:

- 26 (1) "~~Minor~~" as used in this section means a Minor. – A person under 18 years of  
27 age who is not emancipated.
- 28 (2) Unauthorized person. – A person who is not authorized to purchase a firearm  
29 under State or federal law."

30 **SECTION 2.3.(b)** This section becomes effective December 1, 2023, and applies to  
31 offenses committed on or after that date.

## 32 **SALES TAX EXEMPTION FOR FIREARM STORAGE EQUIPMENT**

33 **SECTION 2.4.(a)** G.S. 105-164.13 reads as rewritten:

34 **"§ 105-164.13. Retail sales and use tax.**

35 The sale at retail and the use, storage, or consumption in this State of the following items are  
36 specifically exempted from the tax imposed by this Article:

- 37 ...
- 38
  - 39 (74) Equipment designed to prevent unauthorized access to firearms, including (i)  
40 a device that, when installed on a firearm, is designed to prevent the firearm  
41 from being operated without first deactivating the device or (ii) a gun safe,  
42 gun case, lock box, or other device that is designed, in light of materials used,  
43 to prevent access to a firearm by any means other than a key, a combination,  
44 biometric data, or other similar means. The equipment exempted under this  
45 subdivision does not include a glass-faced cabinet or other form of storage  
46 that is primarily designed to allow for the display of firearms."

47 **SECTION 2.4.(b)** This section becomes effective October 1, 2023, and applies to  
48 sales made on or after that date.

## 49 **AUTHORIZE EXTREME RISK PROTECTION ORDERS**



1 SECTION 2.5.(a) The General Statutes are amended by adding a new Chapter to  
2 read:

3 **"Chapter 50E.**

4 **"Extreme Risk Protection Orders.**

5 **"§ 50E-1. Title of Chapter.**

6 This Chapter may be cited as the "Extreme Risk Protection Orders Act."

7 **"§ 50E-2. Legislative findings and purpose.**

8 (a) Legislative Findings. – The General Assembly finds all of the following:

9 (1) Every year, over 100,000 people are victims of gunshot wounds and more than  
10 30,000 of those victims lose their lives.

11 (2) Individuals who pose a danger to themselves or others often exhibit signs that  
12 alert family, household members, or law enforcement to the threat. Many mass  
13 shooters displayed warning signs prior to the killings, but federal and state  
14 laws provided no clear legal process to suspend the shooters' access to guns,  
15 even temporarily.

16 (b) Purpose. – The purpose of this Chapter is to reduce gun deaths and injuries, while  
17 respecting constitutional rights, by providing a court procedure for concerned citizens and law  
18 enforcement to obtain an order temporarily restricting a person's access to firearms. The court  
19 orders authorized under this Chapter are intended to be limited to situations in which the person  
20 poses a significant danger of harming themselves or others by possessing a firearm and include  
21 standards and safeguards to protect the rights of respondents and due process of law.

22 **"§ 50E-3. Definitions.**

23 The following definitions apply in this Chapter:

24 (1) Extreme Risk Protection Order or ERPO. – An order granted under this  
25 Chapter, which includes a remedy authorized under G.S. 50E-6.

26 (2) Family or household member. – Any of the following:

27 a. A person related by blood, marriage, or adoption to the respondent.

28 b. A dating partner of the respondent.

29 c. A person who has a child in common with the respondent, regardless  
30 of whether the person has been married to the respondent or has lived  
31 together with the respondent at any time.

32 d. A domestic partner of the respondent.

33 e. A person who has a biological or legal parent-child relationship with  
34 the respondent, including stepparents, stepchildren, grandparents, and  
35 grandchildren.

36 f. A person who is acting or has acted as the respondent's legal guardian.

37 (3) Firearm. – Any weapon, including a starter gun, which will or is designed to  
38 or may readily be converted to expel a projectile by the action of an explosive,  
39 or its frame or receiver.

40 (4) Petitioner. – The person who petitions for an ERPO under this Chapter.

41 (5) Respondent. – The person who is identified as the respondent in a petition  
42 filed under this Chapter.

43 **"§ 50E-4. Commencement of action.**

44 (a) Petition. – Either of the following may file a verified petition in district court for an  
45 Extreme Risk Protection Order:

46 (1) A family or household member.

47 (2) A law enforcement officer or agency.

48 (b) Filing Location. – A petition for an ERPO under this Chapter may be filed in any  
49 county permitted under G.S. 1-82.

50 (c) Required Information in Petition. – A petition for an ERPO under this Chapter shall  
51 include all of the following:

1           (1) An allegation that the respondent poses a danger of physical harm to self or  
2 others by having in his or her care, custody, possession, ownership, or control  
3 a firearm. If the petitioner is seeking an ex parte ERPO, the petition shall  
4 include an allegation that the respondent poses an imminent danger of physical  
5 harm to self or others by having in his or her care, custody, possession,  
6 ownership, or control a firearm. The allegation required under this subdivision  
7 shall include facts to support the allegation.

8           (2) An identification, to the best of the petitioner's knowledge, of the number,  
9 types, and locations of firearms under the respondent's custody or control.

10          (3) An identification of any existing protection order under State law governing  
11 the respondent.

12          (4) An identification of any pending lawsuits, complaints, petitions, or other  
13 actions between the petitioner and the respondent.

14          (d) Corroborating Evidence. – A petition for an ERPO under this Chapter shall be  
15 accompanied by either (i) a written statement made by a witness other than the petitioner that  
16 states specific facts supporting the allegation set forth in the petition or (ii) an audio and visual  
17 recording of the incident the petitioner is using as the basis for seeking an ERPO under this  
18 Chapter. A written statement provided under this subsection shall include the name of the witness  
19 and a description of the witness's relationship to the petitioner.

20          (e) Verification of Terms of Existing Orders. – The clerk of court shall verify the terms  
21 of any existing protection orders governing the petitioner and respondent. The court shall not  
22 delay granting relief because of the existence of a pending action between the petitioner and  
23 respondent or the necessity of verifying the terms of an existing protection order. A petition for  
24 an ERPO under this Chapter may be granted whether or not there is a pending action between  
25 the petitioner and respondent.

26          (f) Nondisclosure of Address. – A petitioner with a current and valid Address  
27 Confidentiality Program authorization card issued pursuant to the provisions of Chapter 15C of  
28 the General Statutes may use the substitute address designated by the Address Confidentiality  
29 Program when filing with the court any document required under this Chapter.

30          (g) Court Costs and Attorneys' Fees. – No court costs or attorneys' fees shall be assessed  
31 for the filing or service of the petition, or the service of any ERPOs, except as provided in  
32 G.S. 1A-1, Rule 11.

33          (h) Electronic Filing. – All documents filed, issued, registered, or served in an action  
34 under this Chapter relating to an ERPO may be filed electronically.

35 **"§ 50E-5. Process.**

36          (a) Summons Required. – Except as otherwise provided in G.S. 50E-7, a petition for an  
37 ERPO requires that a summons be issued and served not later than five days prior to the date set  
38 for the full ERPO hearing. Attachments to the summons shall include the petition for any ERPO,  
39 any ex parte ERPO that has been issued and the notice of hearing on the ex parte ERPO, and a  
40 description of what an ERPO is.

41          (b) Service of the Summons and Attachments. – The clerk of court shall effect service of  
42 the summons and any attachments through the appropriate law enforcement agency where the  
43 respondent is to be served.

44 **"§ 50E-6. ERPO requirements; remedy; mental health or chemical dependency evaluation.**

45          (a) Required Information in ERPO. – An ERPO issued under this Chapter shall include  
46 all of the following:

47           (1) A statement of the grounds supporting issuance of the ERPO.

48           (2) The date and time the ERPO was issued.

49           (3) The date and time the ERPO expires.

50           (4) Whether a mental health evaluation or chemical dependency evaluation of the  
51 respondent is required.

1           (5)    The address of the court in which any responsive pleading may be filed.

2           (6)    A description of the requirements for relinquishment and retrieval of any  
3           firearms, ammunition, permits to purchase firearms, and permits to carry  
4           concealed firearms that are in the care, custody, ownership, or control of the  
5           respondent.

6           (7)    A description of the process for seeking termination of the ERPO.

7           (8)    A statement that a violation of the ERPO is punishable as a Class A1  
8           misdemeanor.

9           (b)    Remedy Granted. – Upon issuance of an ERPO, including an ex parte ERPO, the  
10          court shall order the respondent to surrender to the sheriff all firearms, ammunition, permits to  
11          purchase firearms, and permits to carry concealed firearms that are in the care, custody,  
12          possession, ownership, or control of the respondent.

13          (c)    Mental Health or Chemical Dependency Evaluation. – During a hearing for issuance  
14          of an ERPO, the court shall consider whether a mental health evaluation or chemical dependency  
15          evaluation of the respondent is appropriate and may order the respondent to undergo evaluation  
16          if appropriate.

17          **"§ 50E-7. Hearing and issuance of an ex parte Extreme Risk Protection Order.**

18          (a)    Hearing. – Upon receipt of a petition for an ex parte ERPO, the court shall hold a  
19          hearing in person on the day the petition is filed or the judicial day immediately following the  
20          day the petition is filed.

21          (b)    Order. – If the court finds by clear, cogent, and convincing evidence that the  
22          respondent poses an imminent danger of causing physical injury to self or others by having in his  
23          or her custody a firearm, a judge or magistrate of district court may issue an ex parte ERPO  
24          before a hearing for a full ERPO and without evidence of service of process or notice.

25          (c)    Requirements. – An ex parte ERPO granted without notice shall meet all of the  
26          following requirements:

27               (1)    The ERPO shall be endorsed with the date and hour of issuance.

28               (2)    The ERPO shall be filed immediately in the clerk's office and entered of  
29               record.

30               (3)    The ERPO shall include a statement detailing why the ERPO was granted  
31               without notice.

32               (4)    The ERPO shall include the applicable information required under  
33               G.S. 50E-6(a).

34               (5)    The ERPO shall expire by its terms within a specified amount of time after  
35               entry, not to exceed the limits set forth in G.S. 50E-10(a).

36               (6)    The ERPO shall give notice of the date of hearing on the ex parte ERPO.

37          (d)    Appearance by Respondent. – If the respondent appears in court for a hearing on an  
38          ex parte ERPO, the respondent may elect to file a general appearance and testify. Any resulting  
39          ERPO may be an ex parte ERPO governed by this section. Notwithstanding the requirements of  
40          this section, if all requirements of G.S. 50E-8 have been met, the court may issue a full ERPO.

41          (e)    Court Out of Session. – When the court is not in session, the petitioner may file for  
42          an ex parte ERPO before any judge or magistrate designated to grant relief under this Chapter. If  
43          the judge or magistrate finds that the requirements of subsection (a) of this section have been  
44          met, the judge or magistrate may issue an ex parte ERPO. The chief district court judge may  
45          designate for each county at least one judge or magistrate to be reasonably available to issue ex  
46          parte ERPOs when the court is not in session.

47          (f)    Video Conference. – Hearings held to consider ex parte relief pursuant to subsection  
48          (a) of this section may be held via video conference.

49          **"§ 50E-8. Hearing and issuance of a full Extreme Risk Protection Order.**

50          (a)    Hearing. – A court shall hold a hearing on a petition for a full ERPO no later than 10  
51          days from either of the following dates:

- 1           (1)    If an ex parte ERPO has been issued, the date the ex parte ERPO was issued.  
2           (2)    If subdivision (1) of this subsection does not apply, the date the petition for a  
3                full ERPO was filed with the court.

4        A continuance shall be limited to one extension of no more than 10 days unless all parties  
5 consent or good cause is shown.

6        (b)    Order. – A court may issue a full ERPO if all of the following requirements are met:

- 7           (1)    The court finds by a preponderance of the evidence that the respondent poses  
8                a danger of causing physical injury to self or others by having in his or her  
9                custody a firearm.  
10          (2)    Process was served on the respondent in accordance with the requirements of  
11                this Chapter.  
12          (3)    Notice of hearing was given to the respondent in accordance with the  
13                requirements of this Chapter.

14    **"§ 50E-9. Surrender, retrieval, and disposal of firearms.**

15        (a)    Surrender of Firearms. – Upon service of an ERPO, the respondent shall immediately  
16 surrender to the sheriff possession of all firearms, ammunition, permits to purchase firearms, and  
17 permits to carry concealed firearms that are in the care, custody, possession, ownership, or control  
18 of the respondent. In the event that weapons cannot be surrendered at the time the ERPO is  
19 served, the respondent shall surrender the firearms, ammunitions, and permits to the sheriff  
20 within 24 hours of service at a time and place specified by the sheriff. The sheriff shall store the  
21 firearms or contract with a licensed firearms dealer to provide storage.

22        (b)    Failure to Surrender. – Upon the sworn statement of the petitioner or the sheriff  
23 alleging that the respondent has failed to comply with the surrender of firearms required under  
24 subsection (a) of this section, the court shall determine whether probable cause exists to believe  
25 that the respondent has failed to surrender all firearms in his or her care, custody, possession,  
26 ownership, or control. If probable cause exists, the court shall issue a warrant describing the  
27 firearms and authorizing (i) a search of the locations where the firearms are reasonably believed  
28 and (ii) seizure of any firearms discovered pursuant to the search.

29        (c)    Receipt. – At the time of surrender or seizure, the sheriff taking possession of a  
30 firearm shall issue a receipt identifying all firearms that have been surrendered or seized and shall  
31 provide a copy of the receipt to the respondent. Within 48 hours after issuing the receipt, the  
32 officer shall file the original receipt with the court and shall also retain a copy for the sheriff's  
33 records.

34        (d)    Fee. – The sheriff may charge the respondent a reasonable fee for the storage of any  
35 firearms and ammunition taken pursuant to an ERPO. The fees are payable to the sheriff. The  
36 sheriff shall transmit the proceeds of these fees to the county finance officer. The fees shall be  
37 used by the sheriff to pay the costs of administering this section and for other law enforcement  
38 purposes. The county shall expend the restricted funds for these purposes only. The sheriff shall  
39 not release firearms, ammunition, or permits without a court order granting the release. The  
40 respondent shall remit all fees owed prior to the authorized return of any firearms, ammunition,  
41 or permits. The sheriff shall not incur any civil or criminal liability for alleged damage or  
42 deterioration due to storage or transportation of any firearms or ammunition held pursuant to this  
43 section.

44        (e)    Retrieval. – If the court does not enter a full ERPO when the ex parte ERPO expires,  
45 the respondent may retrieve any weapons surrendered to the sheriff unless the court finds that the  
46 respondent is otherwise precluded from owning or possessing a firearm pursuant to State or  
47 federal law.

48        (f)    Motion for Return. – The respondent may request the return of any firearms,  
49 ammunition, or permits surrendered by filing a motion with the court no later than 90 days after  
50 the expiration of the ERPO. Unless the court finds that the respondent is otherwise precluded  
51 from owning or possessing a firearm pursuant to State or federal law, all firearms, ammunition,

1 and permits surrendered by the respondent shall be returned within 30 days of the date the motion  
2 was received by the court.

3 (g) Motion for Return by Third Party. – A third-party owner of firearms or ammunition  
4 who is otherwise eligible to possess the items may file a motion requesting the return to the third  
5 party of any of the items in the possession of the sheriff surrendered or seized as a result of the  
6 entry of an ERPO. The motion must be filed not later than 30 days after the surrender or seizure  
7 of the items by the sheriff. The third-party owner shall also (i) provide proof of ownership of the  
8 firearms or ammunition and (ii) certify that the third-party owner shall not allow the respondent  
9 to have access to the firearms or ammunition. Upon receipt of the third party's motion, the court  
10 shall schedule a hearing and provide written notice to all parties and the sheriff. The court shall  
11 order return of the items to the third party unless the third-party owner fails to provide proof of  
12 ownership or certification as required under this subsection or the court determines that the third  
13 party is disqualified from owning or possessing the items pursuant to State or federal law. If the  
14 court orders the return of the items to the third party, the third party is not required to pay any  
15 fees imposed under subsection (d) of this section. If the court denies the return of the items to the  
16 third party, the items shall be disposed of by the sheriff as provided in subsection (h) of this  
17 section.

18 (h) Disposal of Firearms. – If the respondent or a third-party owner does not file a motion  
19 within the applicable time period prescribed by this section requesting the return of any  
20 surrendered firearms, ammunition, or permits, if the court determines that the respondent or  
21 third-party owner is precluded from regaining possession of any surrendered firearms,  
22 ammunition, or permits, or if the respondent fails to remit all fees owed for the storage of the  
23 firearms or ammunition within 30 days of the entry of the order granting the return of the  
24 firearms, ammunition, or permits, the sheriff who has control of the firearms, ammunition, or  
25 permits shall give notice to the respondent and the sheriff shall apply to the court for an order of  
26 disposition of the firearms, ammunition, or permits. The judge, after a hearing, may order the  
27 sheriff in possession, or the sheriff's duly authorized agent, to destroy the firearms, ammunition,  
28 and permits or to dispose of the firearms, ammunition, and permits in one or more of the ways  
29 authorized by law, including subdivision (4b), (5), or (6) of G.S. 14-269.1. The sheriff shall  
30 maintain a record of any firearms, ammunition, and permits destroyed in accordance with this  
31 subsection. If a sale by the sheriff does occur, any proceeds from the sale after deducting any  
32 costs associated with the storage and sale, and, in accordance with all applicable State and federal  
33 law, shall be provided to the respondent if requested by the respondent by motion made before  
34 the hearing or at the hearing and if ordered by the judge.

35 **"§ 50E-10. Duration; renewal of ERPOs.**

36 (a) Duration of Ex Parte ERPO. – Except as otherwise provided in this subsection, an ex  
37 parte ERPO shall be effective until the date a hearing is held under G.S. 50E-8. If a hearing is  
38 not held or a continuance was not granted, an ex parte ERPO shall be effective for not more than  
39 10 days from the date the ex parte ERPO was issued.

40 (b) Duration of Full ERPO. – A full ERPO shall be effective for a fixed period of time  
41 not to exceed one year.

42 (c) Renewal. – Any ERPO may be renewed one or more times, as required, provided that  
43 the requirements of G.S. 50E-7 or G.S. 50E-8, as appropriate, are satisfied. The court may renew  
44 an ERPO, including an ERPO that previously has been renewed, upon a motion by the petitioner  
45 filed before the expiration of the current ERPO. Upon a motion for a renewal, the court shall hold  
46 a hearing no later than 10 days after the date the motion is filed in court. The court may renew  
47 an ex parte ERPO if the court finds by clear, cogent, and convincing evidence that there has been  
48 no material change in relevant circumstances since entry of the ex parte ERPO. The court may  
49 renew a full ERPO if the court finds by a preponderance of the evidence that there has been no  
50 material change in relevant circumstances since entry of the full ERPO. The commission of an  
51 act of unlawful conduct by the respondent after entry of the current ERPO is not required for an

1 ERPO to be renewed. If the motion for renewal is uncontested and the petitioner seeks no  
2 modification of the ERPO, the ERPO may be renewed if the petitioner's motion or affidavit states  
3 that there has been no material change in relevant circumstances since entry of the ERPO and  
4 states the reason for the requested renewal. Renewals may be granted only in open court.

5 (d) Expiration Date. – An ERPO expiring on a day the court is not open for business shall  
6 expire in accordance with the provisions of Rule 6(a) of the Rules of Civil Procedure, G.S. 1A-1.  
7 **"§ 50E-11. Termination of an Extreme Risk Protection Order.**

8 (a) Motion. – The respondent may request the termination of a full ERPO by filing a  
9 motion with the court. The respondent may submit no more than one motion for termination for  
10 every 12-month period the full ERPO is in effect, starting from the date of the full ERPO and  
11 continuing through any renewals.

12 (b) Hearing. – Upon receipt of a request for a hearing to terminate a full ERPO, the court  
13 shall set a date for a hearing. Notice of the request for a hearing shall be served on the petitioner  
14 in accordance with Rule 4 of the Rules of Civil Procedure, G.S. 1A-1. The court shall set the date  
15 for the hearing no sooner than 14 days and no later than 30 days from the date of service of the  
16 request upon the petitioner.

17 (c) Burden of Proof; Termination. – The respondent shall have the burden of proving by  
18 a preponderance of the evidence that the respondent does not pose a danger of causing physical  
19 injury to self or others by having in his or her care, custody, possession, ownership, or control a  
20 firearm. If the court finds after the hearing that the respondent has met his or her burden, the  
21 court shall terminate the full ERPO.

22 **"§ 50E-12. Notice.**

23 (a) Notice to Law Enforcement; Entry into National Database. – The clerk of court shall  
24 deliver on the same day that an ERPO is issued a certified copy of that ERPO to the sheriff of  
25 the county in which the ERPO is issued. Any order extending, modifying, or revoking an ERPO  
26 shall be promptly delivered to the sheriff by the clerk and served in a manner provided for service  
27 of process in accordance with the provisions of this section. The sheriff shall provide for prompt  
28 entry of the ERPO into the National Crime Information Center registry and shall provide for  
29 access of such orders to the courts on a 24-hour-a-day basis. Modifications, terminations,  
30 renewals, and dismissals of the ERPO shall also be promptly entered. A copy of the ERPO shall  
31 be issued promptly to and retained by the police department of the municipality of the petitioner's  
32 residence. If the petitioner's residence is not located in a municipality or in a municipality with  
33 no police department, copies shall be issued promptly to and retained by the sheriff of the county  
34 in which the petitioner's residence is located.

35 (b) Notice to Respondent. – If the respondent was not present in court when the ERPO  
36 was issued, the respondent may be served in the manner provided for service of process in civil  
37 proceedings in accordance with Rule 4(j) of the Rules of Civil Procedure, G.S. 1A-1. If the  
38 summons has not yet been served upon the respondent, it shall be served with the ERPO. Law  
39 enforcement agencies shall accept receipt of copies of the ERPO issued by the clerk of court by  
40 electronic transmission for service on respondents.

41 (c) Notice to Third Parties. – If the petitioner for an ERPO is a law enforcement officer  
42 or agency, the officer or agency shall make a good-faith effort to provide notice of the petition  
43 to any known third party who may be at risk of unlawful conduct from the respondent.

44 **"§ 50E-13. Prohibition; violation.**

45 (a) Prohibition. – It is unlawful for any person to possess, purchase, or receive, or attempt  
46 to possess, purchase, or receive, a firearm, ammunition, or permits to purchase or carry concealed  
47 firearms, for so long as an ERPO entered against that person in accordance with this Chapter is  
48 in effect.

49 (b) Violation. – A person who violates subsection (a) of this section or any other term of  
50 an ERPO entered pursuant to this Chapter is guilty of a Class A1 misdemeanor.

51 **"§ 50E-14. False statement regarding ERPO a misdemeanor.**

1 A person who knowingly makes a false statement when petitioning for an ERPO under this  
2 Chapter, or who knowingly makes a false statement to a law enforcement agency or officer that  
3 an ERPO entered pursuant to this Chapter remains in effect, is guilty of a Class 2 misdemeanor.

4 **"§ 50E-15. Remedies not exclusive.**

5 The remedies provided by this Chapter are not exclusive but are additional to other remedies  
6 provided under law.

7 **"§ 50E-16. Other authority retained.**

8 This Chapter does not affect the ability of a law enforcement officer to remove a firearm,  
9 permit to purchase firearms, or permit to carry concealed firearms from any person, or conduct  
10 any search and seizure for firearms, pursuant to other lawful authority.

11 **"§ 50E-17. Liability.**

12 Except as provided in G.S. 50E-13 or G.S. 50E-14, this Chapter shall not be interpreted to  
13 impose any criminal or civil liability on any person or entity for acts or omissions related to  
14 obtaining an ERPO, including reporting, declining to report, investigating, declining to  
15 investigate, filing, or declining to file a petition under this Chapter."

16 **SECTION 2.5.(b)** Chapter 15C of the General Statutes reads as rewritten:

17 **"Chapter 15C.**

18 **"Address Confidentiality Program.**

19 **"§ 15C-1. Purpose.**

20 The purpose of this Chapter is to enable the State and the agencies of North Carolina to  
21 respond to requests for public records without disclosing the location of a petitioner for an  
22 Extreme Risk Protection Order or a victim of domestic violence, sexual offense, stalking, or  
23 human trafficking; to enable interagency cooperation in providing address confidentiality for a  
24 petitioner for an Extreme Risk Protection Order or victims of domestic violence, sexual offense,  
25 stalking, or human trafficking; and to enable the State and its agencies to accept a program  
26 participant's use of an address designated by the Office of the Attorney General as a substitute  
27 address.

28 **"§ 15C-2. Definitions.**

29 The following definitions apply in this Chapter:

30 ...

31 (2) Address Confidentiality Program or Program. – A program in the Office of  
32 the Attorney General to protect the confidentiality of the address of an ERPO  
33 petitioner or a relocated victim of domestic violence, sexual offense, or  
34 stalking to prevent the petitioner's or victim's assailants or potential assailants  
35 from finding the petitioner or victim through public records.

36 ...

37 (5a) ERPO petitioner. – The person who petitions for an Extreme Risk Protection  
38 Order under Chapter 50E of the General Statutes.

39 ...

40 **"§ 15C-3. Address Confidentiality Program.**

41 The General Assembly establishes the Address Confidentiality Program in the Office of the  
42 Attorney General to protect the confidentiality of the address of an ERPO petitioner or a relocated  
43 victim of domestic violence, sexual offense, stalking, or human trafficking to prevent the  
44 petitioner's or victim's assailants or potential assailants from finding the petitioner or victim  
45 through public records. Under this Program, the Attorney General shall designate a substitute  
46 address for a program participant and act as the agent of the program participant for purposes of  
47 service of process and receiving and forwarding first-class mail or certified or registered mail.  
48 The Attorney General shall not be required to forward any mail other than first-class mail or  
49 certified or registered mail to the program participant. The Attorney General shall not be required  
50 to track or otherwise maintain records of any mail received on behalf of a program participant  
51 unless the mail is certified or registered mail.

1 **"§ 15C-4. Filing and certification of applications; authorization card.**

2 (a) An individual who wants to participate in the Address Confidentiality Program shall  
3 file an application with the Attorney General with the assistance of an application assistant. Any  
4 of the following individuals may apply to the Attorney General to have an address designated by  
5 the Attorney General to serve as the substitute address of the individual:

6 (1) An adult individual.

7 (2) A parent or guardian acting on behalf of a minor when the minor resides with  
8 the individual.

9 (3) A guardian acting on behalf of an incapacitated individual.

10 (b) The application shall be dated, signed, and verified by the applicant and shall be  
11 signed by the application assistant who assisted in the preparation of the application.

12 (c) The application shall contain all of the following:

13 (1) A statement by the applicant that the applicant is an ERPO petitioner or a  
14 victim of domestic violence, sexual offense, stalking, or human trafficking  
15 and that the applicant fears for the applicant's safety or the safety of the  
16 applicant's child.

17 (2) ~~Evidence~~ Except for an applicant that is an ERPO petitioner, evidence that the  
18 applicant is a victim of domestic violence, sexual offense, stalking, or human  
19 trafficking. For an applicant that is an ERPO petitioner, evidence that the  
20 applicant is at risk from violence or other unlawful conduct from the  
21 respondent in a petition filed under Chapter 50E of the General Statutes. This  
22 evidence may include any of the following:

23 a. Law enforcement, court, or other federal or state agency records or  
24 files.

25 b. Documentation from a domestic violence program if the applicant is  
26 alleged to be a victim of domestic violence.

27 c. Documentation from a religious, medical, or other professional from  
28 whom the applicant has sought assistance in dealing with the alleged  
29 domestic violence, sexual offense, or stalking.

30 d. Documentation submitted to support a victim of human trafficking's  
31 application for federal assistance or benefits under federal human  
32 trafficking laws.

33 ...

34 (4) ~~A~~ Except for an applicant that is an ERPO petitioner, a statement by the  
35 applicant that the applicant has or will confidentially relocate in North  
36 Carolina.

37 ...

38 (7) The address that the applicant requests not to be disclosed by the Attorney  
39 General that directly relates to the increased risk of domestic violence, sexual  
40 offense, ~~or stalking~~ stalking, or other unlawful conduct.

41 ...."

42 **SECTION 2.5.(c)** G.S. 14-415.4(e) is amended by adding a new subdivision to read:

43 "(11) An ex parte or full Extreme Risk Protection Order has been issued pursuant to  
44 Chapter 50E of the General Statutes or a similar out-of-state or federal order  
45 has been issued against the petitioner and the court order issued is still in  
46 effect."

47 **SECTION 2.5.(d)** Development of Forms. – The Administrative Office of the Courts  
48 shall develop the appropriate forms to implement the processes provided under Chapter 50E of  
49 the General Statutes, as enacted by subsection (a) of this section.

50 **SECTION 2.5.(e)** Effective Date. – This section becomes effective December 1,  
51 2023.

5 **ALLOW SCHOOLS TO CONTRACT FOR SCHOOL PSYCHOLOGIST SERVICES**

6 **SECTION 3.1.** G.S. 115C-47(67) read as rewritten:

7 "~~(67) To Provide at Least One School Psychologist.~~ Psychologist Services. – Local  
8 boards of education shall ensure that each local school administrative unit  
9 ~~employs staffs~~ at least one ~~full-time, permanent~~ full-time school psychologist.  
10 If the board is unable to find a qualified school psychologist to hire as a  
11 full-time, permanent employee, the position allocation for the psychologist  
12 may be converted to a dollar equivalent for the board to contract with a third  
13 party to provide school psychologist services for an amount of hours  
14 equivalent to the hours a full-time school psychologist employee would  
15 provide."  
16

17 **CODIFY SCHOOL SAFETY GRANTS**

18 **SECTION 3.2.(a)** Article 8C of Chapter 115C of the General Statutes is amended  
19 by adding a new section to read:

20 **"§ 115C-105.62. School safety grants for students in crisis, training, and equipment.**

21 (a) Definitions. – For purposes of this section, the following definitions shall apply:

22 (1) Community partner. – A public or private entity, including, but not limited to,  
23 a nonprofit corporation or a local management entity/managed care  
24 organization (LME/MCO), that partners with a public school unit to provide  
25 services or pay for the provision of services for the unit.

26 (2) School health support personnel. – School nurses, school counselors, school  
27 psychologists, and school social workers.

28 (b) Program; Purpose. – The Superintendent of Public Instruction shall establish the  
29 School Safety Grants Program (Program). To the extent funds are made available for the  
30 Program, its purpose shall be to improve safety in public school units by providing grants for (i)  
31 services for students in crisis, (ii) school safety training, and (iii) safety equipment in schools.

32 (c) Grant Applications. – A public school unit may submit an application to the  
33 Superintendent of Public Instruction for one or more grants pursuant to this section. The  
34 application shall include an assessment, to be performed in conjunction with a local law  
35 enforcement agency, of the need for improving school safety within the public school unit that  
36 would receive the funding or services. The application shall identify current and ongoing needs  
37 and estimated costs associated with those needs.

38 (d) Criteria and Guidelines. – The Superintendent of Public Instruction shall develop  
39 criteria and guidelines for the administration and use of the grants pursuant to this section,  
40 including any documentation required to be submitted by applicants. In assessing grant  
41 applications, the Superintendent of Public Instruction shall consider at least the following factors:

42 (1) The level of resources available to the public school unit that would receive  
43 the funding.

44 (2) Whether the public school unit has received other grants for school safety.

45 (3) The overall impact on student safety in the public school unit if the identified  
46 needs are funded.

47 (e) Grants for Students in Crisis. – Of the funds appropriated to the Department of Public  
48 Instruction for the grants provided in this subsection, the Superintendent of Public Instruction, in  
49 consultation with the Department of Health and Human Services, shall award grants to public  
50 school units to contract with community partners to provide or pay for the provision of any of  
51 the following crisis services:

- 1           (1) Crisis respite services for parents or guardians of an individual student to  
2 prevent more intensive or costly levels of care.
- 3           (2) Training and expanded services for therapeutic foster care families and  
4 licensed child placement agencies that provide services to students who (i)  
5 need support to manage their health, welfare, and safety and (ii) have any of  
6 the following:
- 7           a. Cognitive or behavioral problems.  
8           b. Developmental delays.  
9           c. Aggressive behavior.
- 10          (3) Evidence-based therapy services aligned with targeted training for students  
11 and their parents or guardians, including any of the following:
- 12          a. Parent-child interaction therapy.  
13          b. Trauma-focused cognitive behavioral therapy.  
14          c. Dialectical behavior therapy.  
15          d. Child-parent psychotherapy.
- 16          (4) Any other crisis service, including peer-to-peer mentoring, that is likely to  
17 increase school safety. Of the funds appropriated to the Department for grants  
18 pursuant to this subsection, the Superintendent shall not use more than three  
19 hundred fifty thousand dollars (\$350,000) per fiscal year for the services  
20 identified in this subsection.
- 21          (f) Grants for Training to Increase School Safety. – Of the funds appropriated to the  
22 Department of Public Instruction for the grant provided in this subsection, the Superintendent of  
23 Public Instruction, in consultation with the Department of Health and Human Services, shall  
24 award grants to public school units to contract with community partners to address school safety  
25 by providing training to help students develop healthy responses to trauma and stress. The  
26 training shall be targeted and evidence-based and shall include any of the following services:
- 27          (1) Counseling on Access to Lethal Means (CALM) training for school health  
28 support personnel, local first responders, and teachers on the topics of suicide  
29 prevention and reducing access by students to lethal means.
- 30          (2) Training for school health support personnel on comprehensive and  
31 evidence-based clinical treatments for students and their parents or guardians,  
32 including any of the following:
- 33          a. Parent-child interaction therapy.  
34          b. Trauma-focused cognitive behavioral therapy.  
35          c. Behavioral therapy.  
36          d. Dialectical behavior therapy.  
37          e. Child-parent psychotherapy.
- 38          (3) Training for students and school employees on community resilience models  
39 to improve understanding and responses to trauma and significant stress.
- 40          (4) Training for school health support personnel on Modular Approach to  
41 Therapy for Children with Anxiety, Depression, Trauma, or Conduct  
42 problems (MATCH-ADTC), including any of the following components:
- 43          a. Trauma-focused cognitive behavioral therapy.  
44          b. Parent and student coping skills.  
45          c. Problem solving.  
46          d. Safety planning.
- 47          (5) Any other training, including the training on the facilitation of peer-to-peer  
48 mentoring, that is likely to increase school safety. Of the funds appropriated  
49 to the Department for grants pursuant to this subsection, the Superintendent  
50 shall use no more than three hundred fifty thousand dollars (\$350,000) per  
51 fiscal year for the services identified in this subsection.

1        (g) Grants for Safety Equipment. – Of the funds appropriated to the Department of Public  
2 Instruction for the grant provided in this subsection, the Superintendent of Public Instruction  
3 shall award grants to public school units for (i) the purchase of safety equipment for school  
4 buildings and (ii) training associated with the use of safety equipment purchased pursuant to this  
5 subsection. Notwithstanding G.S. 115C-218.105(b), charter schools may receive grants for  
6 school safety equipment pursuant to this subsection. In assessing grant applications, the  
7 Superintendent shall prioritize applications for the purchase of any of the following school safety  
8 equipment:

9            (1) Exterior doors with push bars.

10          (2) Erected vehicle barriers.

11          (3) Security systems that monitor and record school entrances, exits, and  
12 hallways.

13          (4) Campus-wide active shooter alarm systems that are separated from fire  
14 alarms.

15          (5) Two-way radio systems.

16          (6) Perimeter security fencing.

17          (7) Bullet-resistant glass or film for school entrances.

18          (8) Door-locking systems.

19        (h) Supplement Not Supplant. – Grants provided to public school units or community  
20 partners pursuant to the Program shall be used to supplement and not to supplant State or  
21 non-State funds already provided for these services.

22        (i) Administrative Costs. – Of the funds appropriated to the Department of Public  
23 Instruction for the grants provided pursuant to this section, the Superintendent of Public  
24 Instruction may retain a total of up to one hundred thousand dollars (\$100,000) per fiscal year  
25 for administrative costs associated with the Program.

26        (j) Report. – No later than April 1 of each fiscal year in which funds are awarded pursuant  
27 to the Program, the Superintendent of Public Instruction shall report on the Program to the Joint  
28 Legislative Education Oversight Committee, the Joint Legislative Oversight Committee on  
29 Health and Human Services, the Joint Legislative Oversight Committee on Justice and Public  
30 Safety, the Joint Legislative Commission on Governmental Operations, the Senate  
31 Appropriations/Base Budget Committee, the House Committee on Appropriations, and the Fiscal  
32 Research Division. The report shall include at least the following information:

33            (1) The identity of each public school unit and community partner that received  
34 grant funds through the Program.

35            (2) The amount of funding received by each entity identified pursuant to  
36 subdivision (1) of this subsection.

37            (3) The services, training, and equipment purchased with grant funds by each  
38 entity that received a grant.

39            (4) Recommendations for the implementation of additional effective school  
40 safety measures."

41        **SECTION 3.2.(b)** The Superintendent of Public Instruction shall establish the  
42 School Safety Grants Program as directed by G.S. 115C-105.62(b), as enacted by this section,  
43 and have the application for the Program available to public school units no later than August 1,  
44 2023.

45        **SECTION 3.2.(c)** There is appropriated from the ARPA Temporary Savings Fund  
46 to the Department of Public Instruction the sum of twenty million dollars (\$20,000,000) in  
47 nonrecurring funds for each year of the 2023-2025 fiscal biennium to fund the School Safety  
48 Grants Program under G.S. 115C-105.62, as enacted by this section. It is the intent of the General  
49 Assembly to fund the Program with recurring funds beginning with the 2025-2027 fiscal  
50 biennium.

51        **SECTION 3.2.(d)** This section becomes effective July 1, 2023.

**PART IV. SEVERABILITY CLAUSE AND EFFECTIVE DATE**

**SECTION 4.(a)** If any Part, section, or provision of this act is declared unconstitutional or invalid by the courts, it does not affect the validity of this act as a whole or any portion other than the portion declared to be unconstitutional or invalid.

**SECTION 4.(b)** Except as otherwise provided, this act is effective when it becomes law.
